PREAMBLE

Name of the project: Rehabilitation and Up-gradation of Kerala Border to Kollegala Section of NH 212 from Km 136.6 to Km 268.475 (excluding Km 239.6 to Km 241.52) in the State of Karnataka to two lanes with paved shoulders/Four lanes Under NHDP-IVA on EPC basis.

1. Considering the public/Police demand a joint site inspection was carried out by PD along with IE on 05.02.2022 and it was observed that few works required immediate rectification in site considering safety of road user. This office has earlier sanctioned an amount of Rs. 47,74,000/- ((including 12% GST) & the same was intimated same to RO Bangalore through e-office no. 391715 for invitation of tender as per NHAI Policy Circular under PD Delegation. Subsequently, due to revision of Schedule of rates the tender which was floated earlier NIT.No.NHAI/PIU/RMNG/NH-212/Maintenance/Tender/2021-22/3638 dated 25.03.2022. The same has been cancelled & new tender is invited based on latest schedule of rates UNI-SR-2021-22 effective from 18.03.2022 as per the revised estimate recommended by IE vide (5) amounting to Rs. 48,80,000/- (including 12% GST). Considering the urgent need for rectification due to road safety issue and to avoid accidents Project Director vide email cited (6) has agreed for tendering with post facto approval on official procedure and accordingly Tender was invited as per the Circular cited above.

2. The bids which are received through online were opened on 21.04.2022 and the bids were evaluated by the Evaluation Committee with the following observations:

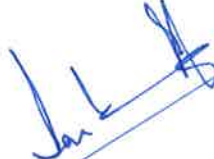
