Minutes of the Meeting of Tender Evaluation Committee dated 06.05.2022 for the works of;

1. Regional Office, NHAI, Madurai invited bids vide Tender ID: 2022_NHAI_113227_1 for the works of "Elimination of 1 No. of Black Spot ID No.TN-02-607 for the year 2015-18 on Trichy - Dindigul section of NH- 45 (New No. 83) in the State of Tamil Nadu [2nd Call]"
2. A Committee has been constituted with the following members;

3. As the subject tender for executing the Blackspot works is invited under 2nd call, it was directed to invite with 15 days of time to submit bids. As such the last date of submission of bids on 02.05.2022 @ 17.00 Hrs and Technical Bid Opening was scheduled on 03.05.2022 @ 17.00 Hrs, respectively.
4. However, the bids submitted through online was opened and decrypted on 04.05.2022 since the scheduled date of opening i.e. 03.05.2022 was a Gazetted Hoilday. During the 2nd call also, 1 No. of Bid only was received through online. The detail of online transaction furnished by the bidder towards Tender Fee & EMD (DD) was furnished to Accounts Division. In response, Accounts Division confirmed that amounts have been received through online has been credited to the Bank Account affiliated with NHAI, RO-Madurai.
