1. The committee in its previous meeting held on 16.06.2022 had recommended to seek the approval of RO Chandigarh to declare the technical bids of two of the bidders as detailed below as technically qualified/responsive and their financial bids may be opened :-

2.	M/s Satish Aggarwal and Co.	Qualified/Responsive
3.	M/s J.P.Y. contractor	NOT Qualified

2. Accordingly, with the approval of RO Chandigarh the date of opening of financial bids of the technically qualified bidders was notified as 23.06.2022. The Committee assembled for online opening of financial bids. The financial bids were opened online as per provisions of bid document in the presence of bidders or their representatives who choose to attend the meeting (Annexure-A) and financial bids were downloaded from e-tender portal. The quoted bid price was announced before all present and is as detailed below: -

3. The committee checked the financial bids for any arithmetical error and found that bids are arithmetically correct. As per comparative statement detailed above, the committee found that bid price quoted by M/s Roadlink Infratech for Rs. 2,11,57,829/- is lowest (downloaded Financial bids enclosed at Annexure-B) and the same was compared with estimated cost of Rs. 2,37,67,500/- and found quoted bid price within sanctioned estimated cost and on lower side of estimated cost by 10.98%.

4. In view of above, the Evaluation Committee recommends M/s Roadlink-Infratech as L-1 Bidder and recommends to award the work to L-1 bidder at their quoted amount of Rs. 2,11,57,829/- (Two Crore Eleven Lacs Fifty Seven Thousand Eight Hundred Twenty Nine Only) which is 10.98% below the Estimated Cost of work. The same is subjected to the approval of Competent Authority.
