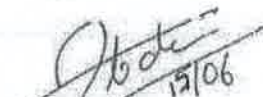

1. During the previous meeting held on 15.06.2022, technical bids were opened online and were taken up for detailed evaluation. The committee has assembled to complete the technical evaluation of bids received from following bidders, namely M/s Roadlink Infratech, M/s Satish Aggarwal and Co. and M/s J.P.Y. contractor.

2. The committee completed technical evaluation of bids as per criteria stipulated in bid document. The committee considered that bid security of one of the bidder M/s J.P.Y. contractor was submitted in the form of FDR duly pledged in the name of NHA1. The same was accepted for further evaluation. It was also brought out that the bidder M/s J.P.Y. contractor has demonstrated no experience in similar category of works as defined in the RFP and hence has been considered Non-Responsive. The Committee was also apprised that a few clarifications were needed in evaluation and the same have been taken from the bidders. The detailed evaluation report is at Annexure-A.

3. The Committee deliberated that as per evaluation report, bid of two bidders is substantially responsive as they have submitted requisite documents, have demonstrated availability of key technical person and have required financial turnover, similar work experience and requisite bid capacity.

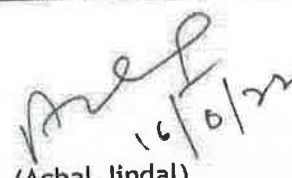

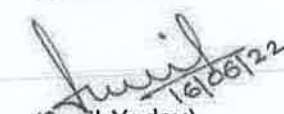
