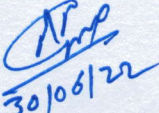

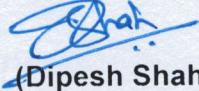

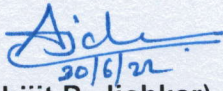
2. Statement of financial offer received from the Technically Responsive Bidder is under:

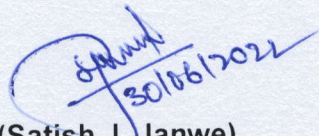

3. From the above Statement, it can be seen that M/s. Sant Satramdas Infrastructure Private Limited has quoted a lowest offer of Rs.2,37,64,586.48 Ps (Say Rs.2,37,64,586/-) i.e. 18.99% below the estimated cost of Rs.2,93,35,374/-. The Committee declared, M/s Sant Satramdas Infrastructure Private Limited is L1 Bidder.
4. As per Policy Circular No. Technical (177/2015), dated 17.04.2015, powers delegated to Regional Officer to approve the lowest bid price is upto 5% above the estimated cost.
5. In view of the above, Committee recommends that the subjected work may be awarded to the L1 Bidder, M/s. Sant Satramdas Infrastructure Private Limited with a quoted offer of Rs.2,37,64,586/- i.e. 18.99% below the estimated cost of Rs.2,93,35,374/-.
