With reference to above cited subject, this office has invited E-Tender vide Tender ID: 2022_NHAI_116458_1 with the following Schedule:

Availability of Bid Documents (last date & time of sale of Bid documents):	From 20.05.2022 Up to 17.06.2022, 1500 Hrs IST.
Last date & time of submission of e-bids (Bid due date):	Up to 20.06.2022, 1500 Hrs IST.
Last date & time of submission of DDs for tender fee and Bid Security Deposit in physical form:	Upto 20.06.2022, 1800 Hrs IST.
The date of opening of bid online:	21.06.2022, 1500 Hrs IST. At Project Implementation Unit, Plot No.1, Sunrise Mega City, In Front of Kishore Nyayalay, Rajghat Road, Baghraj Ward, Sagar (MP)

2. As per tender documents, the tender fee/EMD/Security Details etc. are as under:

(i) **Bid Cost:** - The non-refundable cost for bid document will be Rs. 5,000/- (Five Thousand only)

(ii) **Bid Security:** - Each bidder has to submit the earnest money/bid security for an amount of Rs.10,000/- (For 1 Bolero or equivalent), Rs. 15,000/- (For 1 Scorpio or equivalent) and Rs. 20,000/- (For 1 Innova (Crysta) or equivalent) in the form of online (NEFT)/DD in the name of NHAI, RO-MP, Bhopal as acceptable to NHAI, which will be refundable to the bidder after issuance of LOA to successful bidder but the earnest money of successful bidder will be refundable after signing of agreement.

(iii) **Performance Security:** - The amount of performance security will be equal to the sum of bid evaluated cost as per Terms and Conditions for each vehicle awarded, which will be refundable after successful completion of the contract. The amount will be returned one month after successful completion of service and compliance of all completion after receiving in writing of refund request with bank details.

(iv) The running km shall be adjusted on quarterly basis for short/excess running during the previous months. Although after final settlement no recovery will be made if the vehicle used less than NIT/BOQ mention Km. in a quarterly (i.e. 3500 km x 3months (Innova), 3000 Km X 3months (Scorpio/ Bolero). **In case of surplus running more than 10500 km. (for Innova) and running more than 9000km. (for Scorpio and bolero) additional / extra charges will be paid based on the rates approved by Authority.** The running Rate per extra km. shall be adjusted on quarterly basis as per the excess of average over the monthly celling of the following rates:-

For Innova (Crysta) or equivalent	-	Rs. 12/- per km (Fixed)
For Scorpio or equivalent	-	Rs. 10/- per km (Fixed)
For Bolero or equivalent	-	Rs. 8/- per km (Fixed)

- (iii) Prices are reasonable in comparison to market values.

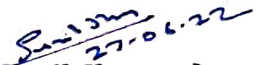
