In connection with the above Tender, following is mentioned for information to all concerned:

- (i) H1 bidder for the subject work i.e. M/s MSV International Inc in Association with M/s ARMENGE Engineering and Management Consultants Pvt. Ltd. has failed to submit proper replacement CVs, delaying the process of interview of the key personnel by the Expert Committee of HO.
- (ii) Considering the need of the urgent deployment of Supervision Consultant on the project, the Competent Authority has accorded approval to declare the H1 bidder i.e. M/s MSV International Inc in Association with M/s ARMENGE Engineering and Management Consultants Pvt. Ltd. as non-responsive in line with NHAI Policy Guideline no. 10.1.30/221 dated 15.11.2021.
- (iii) Competent Authority has also granted approval for calling of fresh financial bids from the following remaining technically qualified firms:

- a) M/s LEA Associates South Asia Pvt. Ltd. in Association with M/s Pioneer Infra Consultants Pvt. Ltd.
- b) M/s K & J Projects Private Limited in Association with M/s Satra services and solutions Private Limited.
- c) M/s Dhruv Consultancy Services Limited in Association with M/s Varad Associates.
- d) M/s L N Malviya Infra Projects Pvt. Ltd. in Association with M/s Intratech Civil Solutions & Consultant.

2. In view of the above,

- (i) The financial bids of the Tender under reference bearing Tender ID no. 2022_NHAI_117331_1 are hereby cancelled.
- (ii) Fresh financial bids from remaining 04 technically qualified bidders as mentioned in para 1 (iii) above are being invited giving time period of 15 days, through separate limited tender on e-tenders portal.
- (iii) It may be noted that all the conditions of original RFP uploaded vide Tender ID no. 2022_NHAI_117331_1 will be applicable for the fresh financial bids & evaluation of the firms will be done considering combined scores of earlier conveyed Technical score and the Financial score as per the fresh financial bids.
