AGREEMENT

This agreement made on **20th October 2022** between the National Highways Authority of India, New Delhi (hereinafter called the Employer on the one part and **M/s AR Thermosets Pvt. Ltd, 104 Chandralok Complex 26/72, Birhana Road Kanpur-208001** (herein after called "the Contractor") on the other part.

AND WHEREAS the Employer invited bids from eligible bidders for the execution of certain works, viz Restoration of alligator cracking on four lane of Baran Shivpuri section from Ch. 1251+814 [615.814 (RJ/MP Border) & 0.00 (MP)] to 1305+087 (54.087 MP) of NH-27 in the state of Madhya Pradesh

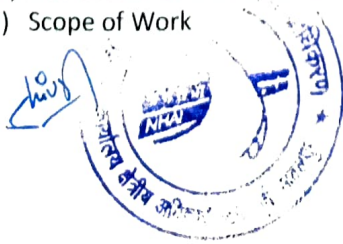
AND WHEREAS pursuant to the bid submitted by the Contractor on **26.06.2022** (herein after referred to as the "BID" or "OFFER") for the execution of the work the employer by his letter of acceptance no. **NHAI/RO-JBL/GWL/NH-27/T-Ramnagar/MS/2022/184 dated 24.09.2022** accepted the offer submitted by the Contractor for execution and completion of such work and remedying of any defect thereon, at a contact price of **Rs 5,56,68,976/- (Rs Five Crore Fifty Six Lacs Sixty Eight Thousand Nine Hundred and Seventy Six only)** on terms and condition in accordance with the document listed in para 2 below:-

AND WHEREAS the contractor by deed of undertaking dated **20th October 2022** has agreed to abide by all the terms of the bid, including but not limited to the amount quoted for the execution of the contract, as stated in the bid, and also to complied with such terms and condition as may be required from time to time.

AND WHEREAS the contractor has agreed to undertake such work and has furnished performance security of Rs. **Rs. 16,70,070/- (Rs Sixteen Lacs Seventy Thousand and Seventy only)** as per the provision of terms and condition of the bid documents.

NOW THIS AGREEMENT WITNESSETH as follows:

1. In this Agreement word and expressions shall have the same meaning as are respectively assigned to them in the condition of the contract hereinafter referred to:
2. The following documents shall be deemed to form and be read and constructed as part of this agreement viz.
 - (a) Agreement,
 - (b) Letter of Acceptance
 - (c) Contractor's Bid,
 - (d) Contract Data,
 - (e) Conditions of Contract
 - (f) Technical specifications
 - (g) Drawing if any
 - (h) Additional Condition and Maintenance Manual
 - (i) Scope of Work



- (g) Bill of Quantities, and
- (h) RFP.

3. The foregoing documents shall be construed as complementary and mutually explanatory to one with another. Should any ambiguity or discrepancy be noted then the order of precedence of these documents shall be subject to the order as listed above and interpreted in the above order of priority.
4. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and remedy any defects therein in conformity in all respects with the provisions of the contract.
5. the employer hereby covenants to pay the contractor in consideration of the execution and completion of the works and remedying of defects therein, the contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
