2. You are requested to return a duplicate of the LOA as an acknowledgement and sign the Contract Agreement within the period prescribed in Clause 1.8 of the RFP.

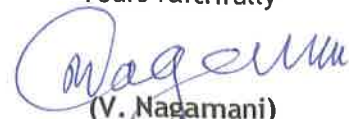

In case of failure of submission of Performance Security, within the time period, the award shall be deemed to be cancelled/ withdrawn and bidder shall be suspended from participation in the tendering process for the works of MoRTH / NHAI / NHIDCL and works under other Centrally Sponsored Schemes, for a period of one year from the bid due date of this work.
