The online Tender was invited vide above said notification for the subject work and following details are incorporated in the RFP and Financial proposal:

As per the Bid Evaluation Committee vide Technical Minutes dated 20.09.2022, 3 nos. of bidders i.e. **M/s. Bhavani Construction and Developers, M/s RR Associates & M/s. Hindustan Construction** were found to be responsive and accordingly recommended to hoist the final outcome of technical evaluation on e-tenders portal of NHAI and to open the Financial Bids of the 03 nos. of Technically responsive bidders **(as mentioned in Annexure-II)** on 22.09.2022 at 15:00 Hrs, if possible.

Accordingly, as per this office vide letter No. 1481 dated 28.09.2022, the Bid Evaluation Committee has opened the Financial Bids of the 03 Nos. of Technically responsive bidders on 29.09.2022 at 16:30 hrs. The details of Financial proposals are as below:

After opening and evaluation of Financial bids **M/s. Hindustan Construction** was **L1** Bidder. As per Section-II vide clause 33.1 of RFP, within 10 (ten) days of the receipt of Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance Security of **Three percent (03%) (Rs.1,01,752/-)** of the Contract Price, valid for the period of 28 days after the expiry of defect liability period of whole work. The DLP as per RFP is 1 year and validity shall Account for additional 45 days time to account for BG verification, signing the contract and start date.

In this regard, the successful L1 bidder **M/s. Hindustan Construction** has to submit Performance Security at **03%** of the Contract price i.e. **Rs.1,01,752/-** within 10 days after receipt of the LOA.

As per NHA policy Road Safety/2022 circular No. 12.25/2022 dated 12/04/2022 & in which clause No. 6.1.1 states that "Project Directors (PDs) are delegated powers to approve rectification of MoRTH notified blackspots through short-term measures upto an amount of Rs. 25 Lakhs per blackspot under Change of Scope (CoS) or Standalone basis.

In view of the above, as per the Policy circular the Bid Evaluation Committee recommends to issue LOA to L1 bidder **M/s. Hindustan Construction** for the quoted amount of **Rs.33,91,738/-** including GST at 12%.

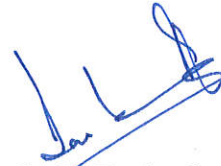
