Sir,

This has reference to your Technical and Financial proposal submitted w.r.t. the subject cited consultancy work.

2. NHAI has accepted your proposal for a contract price of Rs.72,93,000/- (Rupees Seventy Two Lakhs Ninety Three Thousand only) exclusive of GST.
3. The above contract price is inclusive of all taxes (other than Goods and Services Tax), duties, fees, levies and other imposition as may be levied under the Applicable law and NHAI shall deduct taxes as applicable, out of the eligible payments to be made to the Consultant. The amount towards GST shall be paid by NHAI separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities by the consultant.
4. It is requested to sign the duplicate copy of the Letter of Award (LOA) and return the same as your acknowledge within 7 (seven) days of the receipt of the LOA. It is also requested to furnish within 15 days of issue of this LOA, an unconditional Bank Guarantee from Nationalized Bank as per details mentioned in Clause 6 of Letter of Invitation of RFP, for an amount equivalent to 3% of the Quoted Contract Value i.e., Rs.2,18,790/- (Rupees Two Lakhs Eighteen Thousand Seven Hundred and Ninety only) towards Performance Security. This Bank Guarantee shall be as per the relevant format given in the RFP. This Performance Security shall be valid for a period of three years beyond the date of completion of services, or end of civil works contract, whichever is earlier. The said Bank Guarantee shall also be transmitted through SFMS Gateway in designated Bank of NHAI (Canara Bank, A/c No. 8598201005819 and IFSC Code: CNRB0008598).
5. Selected Bidder shall ensure that the credentials w.r.t. qualification and experience being claimed and certified by the firm and individual are correct and genuine. In case of any complaint or deficiency in their services during implementation of project, the same shall be viewed seriously and stern action shall be taken against the firm as per extant guidelines.
6. Upon submission of required Performance Security, you are requested to sign the Contract Agreement as per Clause 9 of Letter of Invitation of RFP. This LOA is issued in terms of Clause 8 of Letter of Invitation of RFP.
