Minutes of Evaluation Committee meeting held on 30.01.2023 @ 15:30 hrs at O/o Regional Officer, Vijayawada for Evaluation of Financial Bids for the work "Independent Engineer Services during Operation & Maintenance Period for Four laning of Gundugolanu - Devarapalli - Kovvuru section of NH - 16 (old SH-107) from Design Ch. Km 15.320 (Existing Km 15.700) to Design Ch.85.204 (Existing Km 81.400) in the State of Andhra Pradesh under Bharatamala Parlyojana on Hybrid Annulty Mode"

Competent Authority vide Office Note dated 25.01.2023 accorded approval for the following:

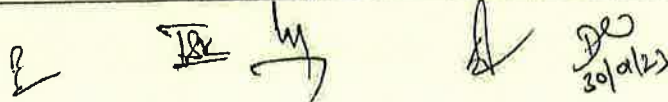
- (i) To upload the results of Technical Evaluation.
- (ii) To intimate all the firms that the Financial bids shall be opened on 30.01.2023 @ 17:00 Hrs at RO, Vijayawada.
- (iii) As per Clause 8 under Section 1. Information to consultants of RFP, the firms scoring the qualifying marks (minimum 75%) shall be listed in the descending order of their technical score and 5 top ranking firms shall only be considered for further evaluation provided none of them is in conflict of interest with the Concessionaire. Accordingly, the financial proposals of following five Technically responsive firms are considered for further evaluation:

(i)	M/s. Artefact Projects Ltd in Association with Renaissance IOT LLP
(ii)	M/s. CMEC Consulting Engineers Pvt. Ltd in Association with TOR Engineers and Consultants Pvt. Ltd
(iii)	M/s. K&J Projects Private Limited in Association with Ruky Projects Private Limited
(iv)	M/s. L.N. Malviya Infra Projects Pvt. Ltd
(v)	M/s. MSV International INC in Association with Armenge Engineering Private Limited

2. Evaluation Committee met on 30.01.2023 at 17:00 Hrs at RO, Vijayawada to open the Financial Bids and observed the following:

- (i) The Technical Evaluation of all the five firms were hosted in the NHAI Website on 27.01.2023 intimating the date of financial bid opening as 30.01.2023 at 17:00 Hrs to all the bidders.
- (ii) No authorized representative was present at RO, Vijayawada during opening of Financial Bids.
- (iii) The financial proposals of the above mentioned five (5) Bidders were opened online for evaluation.
- (iii) The financial proposal was checked for any computational errors in compliance to Clause 5.7 under Section 2: Letter of Invitation to Consultants.
- (iv) As per Clause 8, Section 1 of RFP, the firm shall be selected based on the highest combined score of technical and financial proposal at weightage of 80% and 20% in respect of technically qualified consultancy firm.
- (v) The details of financial proposals are as under:

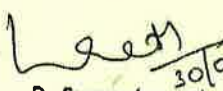

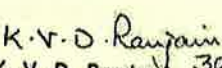
4. In view of the above, Committee recommends the following subject to the approval of the Competent Authority:

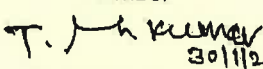

- Thereafter, to seek approval of The General Manager (T) - AP for issue of LOA to most preferred bidder M/s. MSV International INC in Association with Armenge Engineering Private Limited at a Financial Implication of Rs.6,99,00,000/- (Rupees Six Crore Ninety Nine Lakhs only) (excluding GST) for "Independent Engineer Services during Operation & Maintenance Period for Four laning of Gundugolanu - Devarapalli - Kovvuru section of NH - 16 (old SH-107) from Design Ch. Km 15.320 (Existing Km 15.700) to Design Ch.85.204 (Existing Km 81.400) in the State of Andhra Pradesh under Bharatamala Pariyojana on Hybrid Annuity Mode" for a period of 60 months.

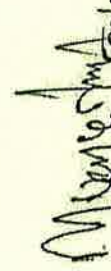

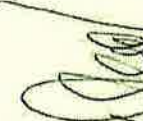

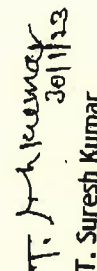
