Please refer to NHA HQ letter dated 15.11.2022 cited under reference (ii) above vide which it was informed that M/s Dilip Buildcon Limited is not-eligible pursuant to Clause 2.1.23 of RFP.

2. M/s DBL vide letter dated 15.11.2022 cited under reference (iii) above has informed that Dilip Buildcon Ltd had filed Writ Petition before Hon'ble High Court of Delhi inter-alia challenging the order of debarment issued by MoRTH amongst the other things. The said matter was listed before Hon'ble High Court on 14.11.2022, the Hon'ble court pleased to grant or stay on impugned order of MoRTH till next date of hearing.

3. The representation of M/s Dilip Buildcon Limited has been examined and it has been observed that the bid due date for instant project is 11.10.2022 and the stay has been granted by Hon'ble HC with effect from 14.11.2022. In this regard, the debarment order remains operational before the date of interim stay. Since, the bidder was debarred on bid due date i.e. 11.10.2022 prior to the operation of said court order, the bidder is non-eligible as per clause 2.1.23 of RFP.

4. In view of above, the financial bid of M/s Dilip Buildcon Limited shall not be opened.

Please refer to NHA HQ letter dated 15.11.2022 cited under reference (ii) above vide which it was informed that M/s GR Infra Projects is not-eligible pursuant to Clause 2.1.23 of RFP. Therefore, the financial bid for the bidder M/s GR Infra Projects Limited shall not be opened.

2. GR Infracorps Ltd vide letter dated 16.11.2022 cited under reference (ii) above mentioned that on date of submission of bids, no such debarment was existing which came only on 10.11.2022 w.e.f 08.11.2022 and therefore has requested to consider them technically eligible and open their financial bids.

3. In this regard, Clause 2.1.23 of RFP may be referred which is as under:

"The Bidder, including an individual or any of its members of its Consortium, should neither be a non-performing party on the date of opening of tender nor on the date of issue of Letter of Acceptance (LoA). Upon declaration of non-performer/debarred, the Concessionaire will not be able to participate in any bid for National Highways projects with MoRTH or its executing agencies till such time the debarment persists or the Concessionaire is removed from the list of non-performer....."

4. Hence the bidder is not-eligible pursuant to Clause 2.1.23 of RFP and therefore, the financial bid for the bidder M/s GR Infra Projects Limited shall not be opened.
