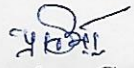
This has reference to your Technical & Financial Proposal submitted for the Subject Consultancy Project.

It is requested to furnish within 15 days of issue of Letter of Acceptance, an unconditional Bank Guarantee equivalent to 5% of the total contract value from a Nationalized Bank as per details mentioned in clause 8.1 of RFP for an amount equivalent to 5% of the Contract Value i.e. Rs.1,14,738/- (Rupees One Lakh Fourteen Thousand Seven Hundred Thirty Eight only) towards Performance Security. The Bank Guarantee expiry of 6 (six) months beyond the date of completion of services contract, whichever is earlier.
