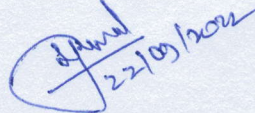
3.0 From the above Statement, it can be seen that M/s. Audarya Construction Private Limited has quoted a lowest offer of Rs.8,45,60,090.57 Ps (Say Rs.8,45,60,091/-) i.e. 30.88% below the estimated cost of Rs.12,23,38,094/-. The Committee declared, M/s.Audarya Construction Private Limited is L1 Bidder.

4.0 In view of the above, Committee recommended that the subjected work may be awarded to the L1 Bidder, M/s. Audarya Construction Private Limited, who quoted a lowest offer of Rs.8,45,60,091/- i.e. 30.88% below the estimated cost of Rs.12,23,38,094/-.
