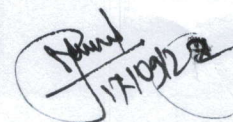

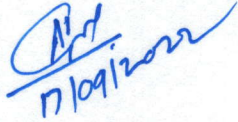
- (i) Earnest Money Deposit / Bid Security

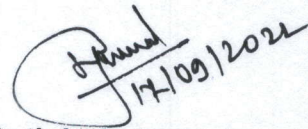
