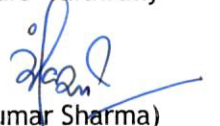

Based on your bid submitted on 02.10.2022 (online) for the work of "Short term improvement and Routine Maintenance of 4 lanning of NH-54E from Km. 300.760 to Km. 275.000 Silchar to Balachera section of NH-54E in the state of Assam, Civil Contract Package, EW-II, AS-01 4th Call" and pursuant to Clause 30 & 32 of ITB, it is hereby notified that your bid for a contract price of **Rs. 27,54,81,864.93/- (Rupees Twenty Seven Crore Fifty Four Lakh Eighty One Thousand Eight Hundred Sixty Four and Ninety Three Paise Only)** which is 17.82% below the estimated cost has been accepted for and on behalf of NHAI.

Thereafter, you are requested to execute the Contract Agreement as per provisions of the RFP and this Letter of Acceptance (LOA).
