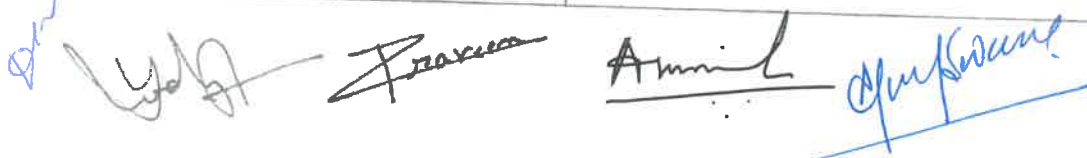

2. No objection/clarification has been received from M/s Tarkeshwar Construction till given time. However, M/s Sarjan Construction Pvt. Ltd. vide letter no. NIL dated 12.10.2022 has submitted clarification. The same has been evaluated by committee in terms of RFP. The pointwise comments of evaluation committee against the submitted clarification is attached as Annexure-1. After detailed deliberation and evaluation of original bid and clarification, the committee declared M/s Sarjan Construction Pvt. Ltd. as non-responsive. 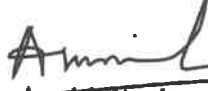

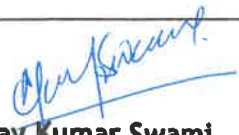

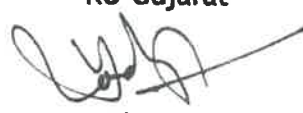

Hence, the claimed work doesn't constitute as similar work. The bidder is non-responsive as per clause 4.4A(b) of section 2 read in conjunction with clause 1.4 (a) of section-3.
2	CV of all other technical personnel provided except site supervisor. Site supervisor is considered to be a junior position and not the key technical personnel hence not provided. However, we undertake that we shall deploy qualified and experienced site supervisor for the project.	The CVs of site supervisors should have been submitted with original bid.
