In continuation to the Technical e-Bids opening & evaluation and with the approval of the RO-Nagpur, the Committee opened the financial e-Bid of technically responsive Bidders' on 25.11.2022 at schedule time. No Bidder's representative attended the opening **(Annex-I)**.

3.0 M/s. Jaswantsingh Oberoi Construction Private Limited has quoted a lowest offer of Rs.10,18,47,321.63 Ps (Say Rs.10,18,47,322/-) i.e. 19.06% below the estimated cost of Rs.12,58,30,642/-. The Committee declared, M/s. Jaswantsingh Oberoi Construction Private Limited is L1 Bidder.

4.0 As per Clause – 12.2 of Bid Document, the Lowest Bidder after evaluation of Bid evaluation result by the Authority, following documents in original to be submitted by the Lowest Bidder:

- Bid Document fee
- EMD / Bid Security
- Power of Attorney for signing the BID(whose digital signature certificate is used during e-tender submission)
- An undertaking from the person having PoA that they agree and abide by the Bid documents uploaded by NHAI and amendments uploaded, if any.
- Affidavit duly notarized

5.0 As per Policy Circular No. Technical (177/2015), dated 17.04.2015, powers delegated to Regional Officer to approve the lowest bid price is upto 5% above the estimated cost.

- 6.0 In view of the above, Committee recommends that the subjected work may be awarded to the L1 Bidder, M/s. Jaswantsingh Oberoi Construction Private Limited with a quoted offer of Rs. Rs.10,18,47,322/- i.e. 19.06% below the estimated cost of Rs.12,58,30,642/- after obtaining the original documents as per Clause-12.2 of Bid Document.



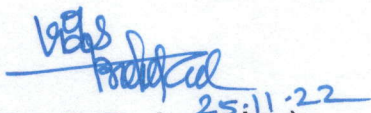
