Minutes of Meeting of Tender Evaluation Committee (Financial Evaluation) dated 20.01.2023 for the work of "Operation and Maintenance for One Year including Incident Management from Km 2+750 to Km 136+543 in Dindigul to Kumili Section of NH-183 (Old NH-45E & 220) in the State of Tamil Nadu" (Tender Ref. No. NHAI/17011/01/61/2022)".

1. Committee evaluated technical bids and recommended the following;

2. Consequent upon approval, financial bids submitted by technically qualified bidders have been decrypted on 20.01.2023 and amounts quoted by them are as under;

As above, Shri T Ramar, Madurai has quoted the rate @ 36.63 % Less, is found as the lowest quoted bid and accordingly, the Tender Evaluation Committee recommends to award the instant tender works to the L-1 bidder, Shri T Ramar, Madurai for an amount of 6,65,38,493/- @ 36.63 % Less (excluding GST) i.e., corresponding amount w.r.t. quoted percentage (36.63% Less).

4. Further, the Committee has observed that, the difference between the rates quoted by the bidders is not much low i.e., less than 10%. Hence, the rate analysis of the price quoted by the bidder does not arise. Also, duly considering the subject Project Highway has been Taken over by the Authority and immediate deployment of O&M agency is highly necessitated, the instant work may be awarded to the lowest quoted bidder i.e., Shri T. Ramar, Madurai & accordingly, the bidder may be requested to furnish Bank Guarantee for an amount of Rs.19,96,155/- i.e., 3% of Bid Price as per Clause 33 of Section-II ITB of RFP.
