This agreement is made the 24th day of March, 2023 between National Highways Authority of India (NHAI), Regional Office, 2nd & 3rd Floor, Vijay Krishna Plaza, No.1, Lake Area, Melur Main Road, Mattuthavani, Madurai - 625 107 (hereinafter called "the Employer") of the one part and M/s Bright Baas Home Foods, No.1, Kiloy Main Road, Sriperumbudur, Kanchipuram - 602 105 (herein after called "the Contractor") of the other part.

AND WHEREAS the Employer invited bids from eligible bidders for the execution of certain works, viz., "Operation and Maintenance of facilities/amenities at Upparpatti Toll Plaza (Km 83/943) on both sides (LHS & RHS) under Highway Nest (Mini) excluding toilets on Dindigul - Kumili Section of NH-183 in the State of Tamil Nadu".

AND WHEREAS pursuant to the bid submitted by the Contractor, vide Bid ID 505428 dated 29.12.2022 (here in after referred to as the "BID" or "OFFER") for the execution of works, the Employer by his Letter of Acceptance dated 22.02.2023 accepted the offer submitted by the Contractor for the execution and completion of such works and remedying of any defects thereon, on terms and conditions in accordance with the documents listed in para 2 below with a monthly rent of Rs.30,300/- (Rupees Thirty Thousand and Three Hundred only) for Kiosks on both the premises on RHS & LHS of Toll Plaza for a period of two years.

3. The foregoing documents shall be construed as complementary and mutually explanatory one with another. Should any ambiguity or discrepancy be noted then the order of precedence of these documents shall be subject to the order as listed above and interpreted in the above order of priority.
4. In consideration of the payments to be made by the Contractor to the Employer as hereinafter mentioned, the Contractor hereby covenants with the Employer to remit the monthly due therein in conformity in all respects with the provisions of the contract.
5. The Contractor hereby covenants to make necessary arrangements to operate the Kiosks and to pay the necessary charges towards electrical, water, etc., in his own, under the provisions of the contract at the times and in the manner prescribed therein.
