Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 10.02.2023 for the work of "Operation and Maintenance of facilities/amenities at Upparpatti Toll Plaza (Km 83/943) on both sides (LHS & RHS) under Highway Nest (Mini) including toilets on Dindigul - Kumili Section of NH-183 in the State of Tamil Nadu" (Tender Ref. No. NHAI/17011/03/05/2022).

1. Regional Office, NHAI, Madurai invited bids vide Tender ID: 2022_NHAI_136944_1 for the work of "Operation and Maintenance of facilities/amenities at Upparpatti Toll Plaza (@ Km 83/943) on both sides (LHS & RHS) under Highway Nest (Mini) kiosks including toilets on Dindigul - Kumili Section of NH-183 in the State of Tamil Nadu".

2. A committee has been constituted with the following members to carry out tender evaluation;

- i. Shri Govindasamy K, DGM (T), RO-Madurai - Convenor
- ii. Shri Harikumar A, DGM (T), RO-Madurai - Member
- iii. Shri P Narasimhan, DGM (Tech) & PD, Trichy - Member
- iv. Shri Mahendra Meena, Dy. Manager (T), RO-Madurai - Member
- v. Shri B Somasundaram, Head, F&A Unit, RO-Madurai - Member

3. Consequent to invitation of bids for appointment of user fee collection agency for upparpatti toll plaza and upkeep/maintenance of adjacent toilet blocks by NHAI, HQ vide Tender ID: 2022_NHAI_137276_1 dated 05.12.2022, in order to avoid overlapping of contract item i.e. Maintenance of Toilet Blocks at Upparpatti Toll Plaza, the same has been removed in the instant tender works vide Corrigendum dated 17.12.2022. As per RFP, last Date of submission of bids and opening of technical bids were scheduled on 30th and 31st December, 2022 respectively.

4. As per MoRTH Circular No. RW/NH-37010/4/2010-EAP (Printing) Vol.IV Dated 30.04.2020, evaluation of bids can be carried out with the available scanned copy of documents as per RFP requirement.

5. Accordingly, the Committee opened the e-bids submitted through online and decrypted. Totally 4 Nos. of Bids were received through online. The details of bids received and Financial Instruments submitted by bidders were furnished to Accounts Division for verification / Confirmation. In response, Accounts Division has confirmed the receipt of payments towards the cost of bid document fee for the instant tender work.

6. In this juncture, consequent upon the repatriation of Shri P Narasimhan, PD-Trichy vide NHAI HQ Officer order No. 11041/508/2021-Admn/E-182531 dated 29.12.2022 & RO-Madurai Office Order No. NHAI/12014/31/2021/RO Madurai/002 dated 02.01.2023, the Technical Evaluation Committee was re-constituted vide Officer Order No. 212 dated 10.02.2023.

7. Subsequently, the Committee has admitted & evaluated the 4 bids on 10.02.2023 based on available scanned copies and the detailed technical evaluation as furnished vide Annexure-A. Summary of the same is submitted hereunder:

8. As seen from above, the Bids received from (i) M/s B.S. Enterprises/Senthilnathan, Erode (Bid ID: 504926), (ii) M/s Bright Baas Home Foods, Sriperumbudur (Bid ID: 505428) & (iii) Shri S Kannan, Dindigul (Bid ID: 505441) are found "Responsive" in the Technical evaluation based on the details furnished by the bidder in compliance with the instructions set forth in RFP.

9. With reference to the bid received from Shri S. Palanichamy, Pudukkottai (Bid ID: 505404) has been considered as "Non-responsive" by the Tender Evaluation Committee after carefully examining and observing that the bidder has not furnished a valid Food Licence Certificate as specified in Clause 5.1 (iv) of Section-I ITB of RFP.

In view of the above, the Committee recommends to accept the bids received from (i) M/s B.S. Enterprises/Senthilnathan, Erode (Bid ID: 504926), (ii) M/s Bright Baas Home Foods, Sriperumbudur (Bid ID: 505428) & (iii) Shri S Kannan, Dindigul (Bid ID: 505441) and considered the bid received from Shri S. Palanichamy, Pudukkottai (Bid ID: 505404) as "Non-Responsive" citing non-compliance towards the instructions set forth in RFP. Committee further decided to meet at a convenient date to open & evaluate financial bids of the technically qualified bidders upon approval of Competent Authority.
