*M/s TPF Gentisa Eurustudios S.L. in association with M/s Segmental Consulting & Infrastructure Advisory (P) Ltd. has been debarred by NHAI vide letter no. DC/53/DraftTermination/NewAE/efile-201323 dated 05.06.2023 for a period of 2 (two)

years from the date of issue of the Order from participating in future NH projects of NHAI/ MoRTH or its executing agencies either directly or indirectly. Accordingly, the bidder has been considered disqualified as per MoRTH letter no. RW/NH-33044/76/2021-S&R(P&B) dated 04.01.2022 which states that "Debarment/ declaration as non-performer of a particular firm shall automatically extend to all its allied firms. But as per the order of Hon'ble High Court issued in the WRIT PETITION (CIVIL) NO. 8619 OF 2023, the financial bid of M/s MDP Consulting in JV with M/s TPF Engineering Pvt. Ltd. is being opened with final technical score as 96.05.

3. As per the directions of the Hon'ble High Court, the financial bids of the technically responsive bidders shall now be opened on 24.07.2023 at 1130 Hrs. in IT Training room, Ground Floor at NHAI HQ.

4. As per the directions given by Hon'ble High Court, the financial bids of technically qualified bidders along with M/s MDP Consulting in JV with M/s TPF Engineering Pvt. Ltd. shall be opened on e-tender portal but the final status of bids shall not be made visible to the bidders and financial bids opened is to be submitted to the Hon'ble High Court. Based on the further directions of the Hon'ble High Court, further necessary course of action shall be taken.
