2. The bidder i.e. M/s TPF Engineering Pvt. Ltd. (TPFEPL) in consortium with TPF Consultores De Engenharia E Arquitetura, S.A (TPF Consultores) and M/s Knight Frank (India) Pvt. was not considered for financial opening of their bid due to debarment of its allied firm. Further, the bidder has filed a petition in Hon'ble High Court for opening of their financial bid.

3. High Court after hearing M/s TPFEPL, ordered opening of their bid and submit the result in a sealed envelope on 25th July 2023.
