The scope of work, accepted rates and terms and conditions applicable to this Letter of Acceptance are as under:

1. Scope of Work:

The scope of work in brief is given below, but the scope also includes all other requirements stipulated in various parts/volumes of the contract document including appendices and annexure:

- 1.1. Site Clearance: The material will have to be removed on "AS IS WHERE IS" and "NO COMPLAINT" BASIS at the contractor's own cost and expenses. The contractor would have to arrange for all the equipment as may be needed for dismantling and transportation. All the safety norms will have to be strictly followed while the dismantling, lifting activity, transportation and site levelling etc. all activities.
- 1.2. The scope of work includes the arrangement of deployment of machineries, deployment of experts and the trained officials for proper planning, supervision, dismantling, disposal, area cleaning, , all running maintenance & repair expenses, fuel, lubricants and any other consumables required from time to time for the machineries to be deployed and for the execution of works, all taxes, duties, incidental charges, penalties etc. as imposed by Central/State/Local Government bodies, including salary and other benefits admissible to staff. Etc. all compete.
- 1.3. The coordination with the NHSRCL officials and other government offices for the successful execution of scope of works is in the scope of the Contractor.

- 1.4. The Contractor shall be responsible for the arrangement of transit pass from the Regional Offices or any authorized signatory/ departments as per the relevant guidelines of road/ surface department and other Government of Gujarat/ Central Government norms.
- 1.5. All Acts, Rules, Regulations & Statutory requirements of Gujarat State to be followed by the successful bidder.
- 1.6. During execution of scope of work, all manpower, machinery, material and safety of adjacent property and public shall be sole responsibility of the contractor.
- 1.7. No unsafe or abnormal dismantling and disposal methods shall be adopted at site which endanger the public, nearby property & animals such as unsafe stacking of dismantled material, any unattended machinery or tools etc.
- 1.8. If the successful bidder/contractor, who is awarded contract fails to make the payment as per the payment schedule or fails to lift the materials in full within the stipulated period, then the employer reserves the right to foreclose/cancel the contract and in such an event, the entire amount available with the employer, under any account head, shall be forfeited. Further, the non-performing bidder/ contractor will be debarred from participation in tender of similar nature of the works.

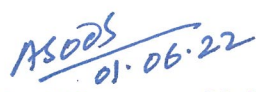

- 2.1. The Contractor shall pay the accepted contract amount to NHSRCL in 3- instalments as described below:
- 2.1.1. 1st Instalment: 50% of the accepted contract amount within 15 days from the date of receipt of LOA.
- 2.1.2. 2nd Instalment: 25% of the accepted contract amount within 45 days from the date of receipt of LOA or completion of the work, whichever is earlier.
- 2.1.3. 3rd instalment equal to 25% of the accepted contract amount within 60 days from the date of receipt of the LOA or completion of the work, whichever is earlier.
- 2.2. The payment by the Contractor to NHSRCL shall be through Demand Draft/ Pay Order drawn in favour of National High Speed Rail Corporation Limited payable at New Delhi, or Bank Transfer/ NEFT/ RTGS in the NHSRCL's bank account. The details of the bank account has been mentioned here under.

5. The completion period of above work will be **90 days (i.e. till 31.08.2022)** from the date of commencement, which may please be noted.
6. Please advise maximum / minimum number of labour that you will engage on the above work contract and register this work with concerned labour department at Vadodara and Ahmedabad.
7. You are also requested to observe the provision of contract labour act (R&A) 1971. So please advise maximum/minimum number of labour that will be engaged by you on the above work. Any failure of the provision of the said act that will attract penal provision, which may please be noted. Necessary certificate authorizing your engagement is enclosed herewith. Information required as per form VI may be submitted to LEO/(c)/Vadodara & Ahmedabad endorsing the copy to this office immediately on commencement to the work.
