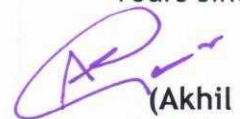

percent) of total Contract Value/Price in the form of D.D./Banker's cheque /FDR/BG in prescribed format in favor as specified in Annexure XVI of Section-IV. Failure to comply with this requirement shall constitute sufficient grounds for the annulment of the Award.

5. Subsequent upon submission of the Performance Security, you are required to sign the work Contract Agreement in accordance with Clause 1.10 of ITB of the tender document.

6. The date of commencement of services shall be reckoned from the date of issuance of Letter of Award.
