The contract agreement shall be executed on a non-judicial stamp paper of value of Rs.100/- (Rupees Hundred only) and the cost of stamp paper shall be borne by you.
- 3) The Earnest Money Deposit amount of **Rs. 77,600/-** (Rupees Seventy seven thousand and six hundred only) received along with your tender has to be credited after uploading of AOC in e-procurement portal. Please deposit **Rs. 3,11,733/-** (Rupees Three lakhs eleven thousand seven hundred and thirty three only) towards Security Deposit within 15 days from the date of issue of this letter, failing which, the same will be deducted from your running bills as per Clause – 1A, page – 15 & 16, of the tender document.
- 4) You are requested to comply with the provision of contract Labour (Regulation and abolition) Act of 1970 and contract Labour (Regulation and abolition) Central Rules 1971 and Minimum Wages Act & Rules there of Central and State Governments.

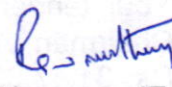
