1. M/s. Ponmani International (India) Pvt Ltd-
 - (i) Form B submitted is not as per the format as per NIT
 - (ii) Balance sheet/PL Statement indicates continuous losses for last 3 years which is not acceptable as per NIT.
2. M/s. Kalpex- Not Eligible due to following reasons,
 - 1 .As per NIT, Experience gained by executing work on back-to-back contract/ Sub-contract basis is not accepted since tripartite agreement/ written approval of the client along with valid agreement and experience certificate for the work executed by the second agency (sub-contractor) not submitted.

 3. Net worth certificate as per Form C given in Tender Document TAF-5 certified by CA with UDIN not submitted.

For the work experience submitted from Govt / PSU organizations such as AIIMS,IOCL,ONGC,CPWD, work completion certificate issued by the Client mentioning name of work, name of client, nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory not submitted.

For the work experience submitted from Non Govt/Non PSU organizations such as Shikhar, copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work not submitted.

Remaining One (01) No. Bidder that is M/s. Sterling and Wilson Pvt. Ltd is not meeting the eligibility criteria due to following Reasons hence not qualified for opening of Cover-II.
