Sir/Madam,

The approval of Competent Authority is hereby conveyed for the award of License to Operate Staff Canteen at Coimbatore International Airport to M/s Selvi Enterprises, 18/97, Mahakavi Nagar, Irugur, Coimbatore – 641 103 as per the following terms and conditions:

1	Licence for	Staff Canteen at Coimbatore International Airport
2	Tentative Location	Area: 201.37 sqm(approx.) (Cityside) The area is subject to actual measurement.
3	Period of the Licence	03 (Three) years
4	Licence Fee	Rs. 21,400.00/- (Rupees Twenty-One Thousand Four Hundred Only) plus applicable taxes per month plus utility at 10% of space rent excluding Common Area (Prevailing Non-AC space rent - Rs.1700/- per sqm per month) and other charges as applicable. License fee should be paid on or before 25th of the same month, failing which interest on delayed payment at the rate of 9% per annum shall be charged from the due date for delay period of upto 30 days and if delay is for more than 30 days, then interest at the rate of 18% per annum shall be charged from the due date, for entire delay period.
	Annual Escalation	License Fees shall be subject to annual escalation of 10%. The first annual escalation will be applicable after completion of one year + six months license period. Thereafter the same will be applicable after completion of subsequent one year period there from. Even if, on account of any delay whatsoever, licensee could not commence business operations on the expiry of gestation period stipulated in NIT, for the purpose of calculation of date on which 18 months of license are completed (date on which first escalation is applied) shall be deemed from next day of expiry of gestation period stipulated in NIT.
5	Charges for electricity & Water	As per Bills issued at applicable rates.
6	Security Deposit	Rs.1,57,000/- (Rupees One Lakh Fifty Seven Thousand only) amounting to 04 (four) months equivalent Concession fee of the first year to AAI as an interest free Security Deposit shall be paid in the form of DD/Pay order/Bank Guarantee in favour of Airports Authority of India, Coimbatore Airport within 15 days from the date of issue of award letter. The SD amount equivalent to four months concession fee to be submitted in the form of BG from any scheduled commercial bank (Bank

		Guarantee from co- operative bank, even scheduled, will not be accepted) or by way of NEFT/RTGS or DD/PO. The BG should be valid for the complete period of licence plus 6 months beyond the licence period. No interest is payable on SD.
7	Interest on delayed payment	As per terms and conditions of NIT.
8	Security deposit for Electricity/ water/telephone	Rs.20,000/- (Rupees Twenty Thousand only) by way of Demand Draft/Pay order/Bank Guarantee payable to Airports Authority of India at Coimbatore.
9	Advance license fee	Rs.39,202/-(Rupees Thirty Nine Thousand Two Hundred and Two only) including GST @ 18%.
10	Obligation of Govt. laws/rules	The licensee, his agents and servants shall observe, perform and comply with all rules and regulations of Shop and Establishment Act, Factories Act, Industrial Disputes Act, Minimum wages Act and any rules and regulations made by Govt./Airports Authority of India.
11	Business Incubation period	15 days from the date of issuance of LOIA
12.	Gestation Period	30 days reckoned from the date of handing over of sites shall be permissible.

13. It may be noted that the Earnest Money Deposit of the successful bidder may be forfeited and the bidder shall be liable to be debarred for further participation in AAI's tender(s) /e-tender(s) for a period of one (01) year, on account on non- completion of the following:

- Acceptance of the offer within 07 (seven) days from the date of issuance of the award letter addressed to the party.
- Payment of advance license fee for one month within 15 days from the date of issuance of the award letter.
- Payment of Performance Security Deposit within 15 days from the date of issuance of award letter.
- Execution of the Agreement within 15 days from the date of issuance of award letter (on stamp paper of appropriate value, related costs to be borne by the Licensee).
- Commencement of the facility within the stipulated period.

14. The licensee should submit attested copies of all the necessary licenses obtained for operating the catering services like FSSAI, etc. before commencement within 15 days of LOIA.

15. One copy of this award letter may be returned to this office duly signed along with the acceptance letter /token of having accepted the terms and conditions of the award.

16. In the event of the Licensee committing any breach of the terms and conditions of the license agreement, the Authority may without prejudice to other rights and remedies be entitled to forfeit the Security Deposit or any part thereof. On the expiration or earlier determination of the license the Authority shall return the Security Deposit or part thereof which has not been forfeited as aforesaid, to him, without interest.

19. All the above conditions along with those mentioned in the E-tender shall be binding on the licensee.
