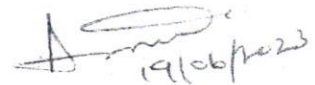

The Contract Agreement shall be executed on a non-judicial stamp paper of value of Rs.100/- (Rupees Hundred only) and the cost of the stamp paper shall be borne by you.

You are directed to deposit Rs.7,20,450/- (Rupees Seven Lakhs Twenty Thousand Four Hundred and Fifty only) toward security deposit within 10 days from the date of this letter, failing which, 10% of value of work done will be deducted from the running account bills as security deposit as per condition of Clause No. 1(A) on page no.39 of the Tender Document. The Earnest Money Amount of Rs.1,61,566/- (Rupees One Lakh Sixty one Thousand Five Hundred and Sixty Six only) received on line payment through CPP portal along with your tender will be refunded after your depositing of security deposit or after adjustment of the EMD amount as security deposit from the running bills.

5. You are also directed to contact Asst. Gen. Manager (Engg-Civil), AAI/SR, Chennai Airport, Chennai - 600 027 immediately who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work shall be **5 (Five) months** and same shall be reckoned from **the 10th day** after issue of this letter.

8. Necessary BCAS clearance to execute the work at Airport/Obtaining Security/Entry Passes has to be obtained through e-sahaj portal.
