Subject:- Debarment of M/s Nakkashi (Partnership Firm) from participating in any AAI tenders for a period of one (01) year and forfeiture of EMDs.

- 1) Award letter dated 19.09.2023 for Licence for Retail Outlet for Books and Toys inside Domestic SHA (Ground floor) at SGRDJI Airport, Amritsar (Tender ID 2023_AAI_153986_1)
and
- 2) Award letter dated 19.09.2023 for Licence for Retail Outlet for Handicrafts, Decor items & Accessories inside Domestic SHA and International SHA at SGRDJI Airport, Amritsar (Tender ID 2023_AAI_153987_1)

Sir,

- 1) This has reference to your participation in two different tenders (Tender ID 2023_AAI_153986_1 and Tender ID 2023_AAI_153987_1) invited by this airport through NIC CPP Portal and awarded to your firm (M/s Nakkashi) vide award letters dated 19.09.2023 as mentioned under reference.
- 2) The subject award letters were accepted by your firm vide email dated 27.09.2023.
- 3) As per award and tender conditions, you were required to submit one-month advance licence fee, Payment of security deposit and execution of agreement within 15 days of issuance of award letters. But you did not make these compliances even after expiry of gestation period. In this regard, various reminders were issued from time to time in the form of letters / emails.
- 5) Accordingly, the Show Cause Notice was issued on 02.02.2024 that why appropriate action should not be taken against you as per provisions contained under Clause-14(h) of NIET and Clause-5 of General Information & Guidelines of tender documents.
- 6) After receipt of your inappropriate reply of Show Cause Notice on 13.02.2024 i.e. after 10 days of timelines, the personal hearing was also given to you to present before AAI prior to process of debarment. In the personal hearing on 06.03.2024, your

representative informed AAI about the incompetence to take the licenses forward. In this regard, an email dated 07.03.2024 has also been sent by you submitting only reasons for non-compliances.

- 7) Therefore, M/s Nakkashi (Partnership Firm) is hereby debarred from participating in any tender of AAI for a period of 01 (one) year from the date of issuance of this letter and also your EMD of both the tenders has been forfeited as per provisions contained under Clause-14(h) of NIET and Clause-5 of General Information & Guidelines of tender documents.
