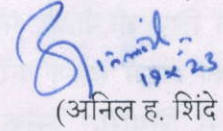

- Convey your acceptance of this award letter within 5 days from issue date of Award letter and be ready to pay the advance license fee amount of Rs. 1,27,260.00/- through Bank Guarantee of any nationalized/scheduled bank within 15 days from issue date of award letter.
- Submit deposit amount of Rs. 7,63,560/- (Equal to three months of the quoted license fee with facilitation charges plus GST@18%) as Security Deposit in the form of Bank Guarantee of Nationalized/Scheduled Bank in favour of Airports Authority of India within 15 days from issue date of this letter. Bank Guarantee from Co-operative Banks will not be accepted.
- Submit the Agreement on non-judicial stamp paper of Rs. 100/- for this contract as per details given in NIT. The agreement should be submitted in quadruplicate (01 original plus 03 photocopies).
