We are pleased to inform you that your offer for Rs. 1,44,444.0/- per month (Excluding all applicable taxes) for first year license fee has been accepted by the competent authority.

इस विषय में उपरोक्त टेण्डर के निम्नलिखित बिन्दुओं को ध्यान देने की आवश्यकता है (The following point of the above tender needs to be noted):-

- 1) License period of the Contract shall be 03 years from the commencement of operation from Interim Terminal Building.
- 2) Gestation period of 15 days will be allowed. The gestation period will start from the date of handing over of Space in the arrival.
- 3) Only vacant space measuring 6 sq. mtr. Shall be allotted in arrival of Rajkot International Airport as per location plan in NIT. You will have to construct your own structure in the space allotted.



- 4) Amount of License fee payable for the first year from commencement of operation from Interim terminal building/Handing over of Parking space shall be Rs. 1,44,444.0/- per month (plus all applicable taxes & Utility/facilitation charges as per tender conditions).
- 5) You are requested to complete the following as per the timeline mentioned:
 - a) Convey your acceptance of terms and conditions of this LOIA and the NIT on a duly signed duplicate copy of this LOIA within 5 days from issue date of this letter and pay the advance license fee amount of Rs. 1,70,819.16/- (License Fee plus 18% GST) through Demand Draft or Pay order of any nationalized/scheduled bank within 15 days from issue date of this letter.
 - b) Submit security deposit amount of Rs. 6,83,276.64/- (Equal to three months of the quoted license fee with facilitation charges plus GST@18%) as Security Deposit in the form of Bank Guarantee of Nationalized/Scheduled Bank in favour of Airports Authority of India within 15 days from issue date of this letter. Bank Guarantee from Co-operative Banks will not be accepted.
 - c) Submit the Agreement on non-judicial stamp paper of Rs.100/- for this contract as per details given in NIT. The agreement should be submitted in quadruplicate (01 original plus 03 photocopies). Signature of both the parties shall be original on all the copies. The cost of the stamp paper shall be borne by the licensee.
- 6) Please intimate the names of all persons employed by you or going to be employed by you.
- 7) You shall comply with all the requirements as set out in the NIT, and for all purposes the conditions of the NIT, Corrigendum(s) and Agreement form a part of this LOIA and shall be read as a part of this LOIA.
- 8) All terms and conditions of the license as per tender document shall be applicable.
