**Short Fall required :-**

1. Agency has not submitted Form-A).
2. Agency has not submitted Financial Information (Form-B).
3. Agency has not submitted Net Worth (Form-C) Certificate as per NIT.
4. Agency has not submitted Tools and Plant undertaking.

Bidder has submitted all the document as per NIT criteria.

**C. M/s Anshu Aman Construction and Services Pvt. Ltd., Boring Road, Patna 800001**

1. The agency is currently doing Annual Maintenance Contract for the Terminal Building at JPNI Airport, Patna for the year 2022-23 vide Work Order No. AAI/PAT/AGM(Engg.-C)/W.O.-03/2022-23/1924-30, dtd. 07.07.2022 & Agreement No. AAI/PAT/Jt. G.M.(Engg.-C)-01/2022-23, dtd. 14.07.2022.
2. As per records, it has been observed that the agency has very poor performance and the agency is unable to complete various assigned work on time. Various intimations vide mail/ letters and Work Instruction Register have been issued in this regard. This has led to negative feedbacks from stakeholders especially from passengers.  
Also, the agency has not deployed supervisor and work has been badly affected due to this. Recovery for the same has been made vide AAI Letter No. AAI/PAT/Jt.GM.(Engg.-C)/3008 dated 03.05.2023 and Letter No. AAI/PAT/Jt.GM.(Engg.-C)/3142 dated 05.06.2023
3. The agency has made the payment for the month of November 2022 and April 2023 on 14.06.2023 and for May 2023 on 15.06.2023 after several requests and reminders. Also, the agency has not made the payment for June 2023 till date i.e. till 13.07.2023.  
As per Clause No. 17 (iii) of Special Condition of Contract (Civil works), of the above referred Agreement ***"If any violation with respect to payment of wages for any two months in a contract period, necessary action for cancellation of contract, debarring of the agency for participating in future contracts in AAI shall be initiated. The agency will not be allowed to participate in any of the tendering process in AAI till finalization of the decision."***
4. The agency has not paid EPF to manpower engaged in ongoing TB AMC work at JPNI Airport, Patna since the start of work i.e. from 18.07.2022 till date defying various letters/emails from AAI e.g. dated 03.05.2023, 05.06.2023, 07.06.2023, 09.06.2023 & other several correspondences made in this regard. This is a serious violation of Labour Laws.
5. The behaviour of the Agency has been found to be unprofessional. The Agency has purportedly been found to be in violation of safety and security norms as reported by from Sr. Commandant, CISF and same being intimated to the Agency by AAI vide Letter No. AAI/Patna/Jt.GM(Engg.-Civil)/9155-56 dated 20.04.2023. However similar complaint has been received subsequently from Duty Terminal Manager vide email dated 27.06.2023.  
Also the Agency has threatened AGM (Engg.-Civil) during office hours on 09.06.2023, intimation for which has been given to APD, JPNI Airport Patna and Jt. G.M. (Engg.-Civil) vide email dated 10.06.2023.
6. The agency has not submitted response with regard to the Show Cause Notice from AAI vide Letter No. AAI/PAT/Jt.GM(E-C)/3155 dated 12.06.2023 with regard to ongoing AMC work (AMC TB 2022-23) of the terminal building at JPNI Airport, Patna.  
Hence as per Clause No. 9 (at Page No. WNIT-6) of the tender [Tender ID: 2023\_AAI\_157690] this agency is recommended as ***"NOT ELIGIBLE."***
