Please deposit balance amount **Rs.1,47,528/-(Rupees One Lakh Forty Seven Thousand Five Hundred and Twenty Eight Only)** towards security deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition of clause 1A on page GCC 23-24 of GCC of contract document.
