The SD is to be furnished either through Bank transfer via NEFT/RTGS in AAI Gwalior account or in the form of BG issued by Nationalized/Scheduled Bank having a validity of 180 days from the date expiry of the Contract. BG from Cooperative Bank (even scheduled) or in the form of FDR is not acceptable. 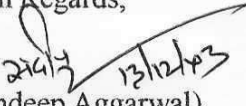
