Technical Bids have been opened on 09.11.2023, five parties namely M/s Aman Tea Distributors Pvt. Ltd., M/s Bhavisya Nirman Pvt. Ltd., M/s R K Enterprises, M/s RBA Hospitality and Hotels Pvt. Ltd. and M/s Saptagiri Restaurant Pvt. Ltd. have participated. Technical documents have been scrutinised by the officials, Subharaj Maitra, Manager (Comm), S. N. Thakur, Manager (Fin) & S.C.Basak, AGM(ATSEP). Some of the supporting documents are not submitted by the bidders namely M/s Bhavisya Nirman Pvt. Ltd., M/s R K Enterprises, M/s RBA Hospitality and Hotels Pvt. Ltd as per the NIT which was sought through NIC CPP Portal as shortfall documents. After scrutiny of further clarification submitted the bidders, four bidders have been found technically qualified, one bidder namely M/s Saptagiri Restaurant Pvt. Ltd. was debarred from Amritsar Airport for participating in future tenders of AAI for a period of three years w.e.f. 08.08.2023. Accordingly the bidder namely M/s Saptagiri Restaurant Pvt. Ltd. is technically disqualified and financial bid of four bidders namely M/s Aman Tea Distributors Pvt. Ltd, M/s Bhavisya Nirman Pvt. Ltd., M/s R K Enterprises and M/s RBA Hospitality and Hotels Pvt. Ltd. may be opened on 30.11.2023 at 1700hrs.
