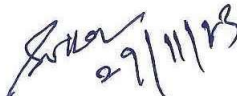

Ltd., M/s A.K.Agency, M/s Crunch Foods, M/s Rainbow Travels, M/s Sweet And Salt, M/s VIP Services, M/s Travel Retail Services Pvt. Ltd., M/s RBA Hospitality and Hotels Pvt. Ltd. and M/s Bhavisya Nirman Pvt. Ltd. have participated. Technical documents have been scrutinised by the officials, Subharaj Maitra, Manager (Comml), S. N. Thakur, Manager (Fin) & S.C.Basak, AGM(ATSEP).
