Sir,

Reference is invited to your Technical Bid (Bidder name: Pinnintigopalkrishna) vide above tender ID opened on 20.11.2023, subsequent Financial Bid opened on 11.01.2024 in respect of above cited license. Competent Authority has accepted your bid and approved to award the license for the subject facility on the following terms and conditions.

1. The award of license shall be for a period of **04 (Four) years extendable by one year** with an area of **112 sq. mts.** for operating staff canteen facility, opp. ANS Complex of Visakhapatnam Airport.
2. The license fee shall be the quoted license fee of **Rs. 25,001/- (Rupees Twenty-Five Thousand and One only)** per month plus applicable charges and taxes to be payable to AAI during the period of license. License Fees shall be subject to annual escalation of 10%. The first annual escalation will be applicable after completion of twelve (12) months license period. Thereafter the same will be applicable after completion of subsequent one-year period there from. However, utility/ facilitation charges for allotted space are **NOT applicable**, as per policy.
3. (a) The successful bidder has to obtain all the requisite statutory/ Regulatory permission & certification etc. as per the time line mentioned in the NIET from the date of award of work. In case of failure in obtaining the requisite statutory/ regulatory permission & certification etc. as per timeline mentioned in the NIET, the award will be cancelled.
(b) The Licensee shall not surrender the subject license before the expiry of 50% of the period of license, failing which the licensee shall be debarred from participating in any of AAI's tenders for a period of 1 (one) year and also applicable other terms & conditions as per exit clause of NIET.
4. AAI will raise bills on or before 10th of every month and the licensee has to pay the bill on or before 25th of every month, failing which interest on delayed payment at the rate of 9% per annum shall be charged from the due date for delay period of up to 30 days, then interest at the rate of 18% per annum shall be charges from

the due date, for entire delay period, without prejudice to Authority's other rights and remedies.

5. The licensee shall be required to submit Security Deposit of **Rs. 1,77,000/-** (Rupees One Lakh Seventy-Seven Thousand only) equivalent to 6 (Six) months of 1st year license fee (including amount equivalent to GST @ 18%) in the form of RTGS/ Bank Guarantee from Scheduled/Nationalized Bank in favour of Airports Authority of India, payable at Visakhapatnam with claim period of 180 days. The Licensee shall also be required to submit Security Deposit for Electricity charges i.e. **Rs. 18,000/-** (Rupees Eighteen Thousand only) in the form of RTGS only.

6. It may be noted that the EMD may be forfeited and you may be debarred from further participation in AAI's tenders for a period of 1 (one) year on account of non-completion of the following:

- Acceptance of offer within **7 days** from the date of issue of this letter.
- Payment of advance license fee for one month of **Rs. 29,502/-** (Rupees Twenty-Nine Thousand Five Hundred Two Only) including GST @ 18% in the form of RTGS in favour of Airports Authority of India, payable at Visakhapatnam within 15 days from the date of issue of this letter.
- Submission of Security Deposit of **Rs. 1,77,000/-** in the form of RTGS/BG & Electricity Deposit of **Rs. 18,000/-** in the form of RTGS within 15 days from the date of issue of this letter.

Note: Bank details of AAI, Visakhapatnam are enclosed as ANNEXURE: 1.
Submission of BG shall be as per format provided in NIET Document.

- Depute any authorized representative for the joint measurement within 15 days from the award letter. The joint measurement shall from part of agreement. If the party fails to depute any authorized representative for the measurement within 15 days, then AAI representative shall conduct the measurement and inform the party that the same will be forming part of agreement and will be binding.
- Execution of license agreement on non-judicial stamp paper of **Rs.500/-** Govt. of Andhra Pradesh within 15 days the date of issue of award of letter.

7. The licensee shall not damage the premises or any part of the Airport Premises. In the event of any damage being caused intentionally or otherwise, AAI shall be entitled to repair the damage or make the requisite replacement and call upon you to replace or reimburse the cost thereof for which you shall have to pay forthwith on demand. In addition, AAI in any way will not be held responsible for any theft/pilferage etc. You shall have to make/provide necessary security arrangement for safety / security of the belongings at your own cost.

8. That the Authority reserves to itself the right to change the location of the premises at any time and may at its discretion to call upon the licensee to vacate

the site and may give alternative premises for the purpose of this license. In such a case, the licensee shall be bound to vacate the premises immediately and accept the said alternate premises. The entire expenditure on such shifting shall be borne by him and the licensee shall not be entitled to claim any compensation or revision in the license fee on that score.

9. The license can be terminated by either side, by giving **120 days'** notice in writing. However, Airports Authority of India can terminate the contract on short notice, on grounds of unsatisfactory performance of passengers/users' complaints. In such an event, licensee shall vacate the premises and handover peaceful possession of the licensed premises to AAI without claiming any compensation or raising any dispute.

10. The licensee shall be required to meet all statutory taxes/levies to the Central/state/local bodies as prescribed, if any, failing which AAI may exercise its option to settle, on licensee's behalf and recover the amount from the licensee. No claim in any respect regarding his property/goods shall be entertained by AAI.

11. The Licensee shall make arrangements to obtain appropriate insurance cover in respect of all properties/goods, if any, proposed to be stored or used by the licensee.

12. AAI reserves the right to grant license for similar facilities in the same/ different locations of the airport and enter separate commercial agreements with other firms/individuals and licensee shall have no objection for the same.

13. Following acts of licensee shall also be construed as grounds for Termination of contract:

- (a) Unsatisfactory performance.
- (b) Non-payment of dues/ partial payment of dues.

14. All other terms and conditions which are specified in the NIET, shall also form an integral part of the license agreement.

15. Business Incubation Period: - **15 days** of business incubation period from the date of issuance of LOIA shall be applicable for completing post award facility by the Licensee such as award acceptance, submission of SD/BG, execution of Agreement, taken over the site, submission of security clearance documents of BCAS etc.

16. GST and Cess as applicable from time to time is payable by the licensee.

17. Agreement is to be executed on a non-judicial stamp paper of **Rs.500/-** of Govt. of Andhra Pradesh and submission of the same to this office along with the photograph of authorized signatory (with documentary proof of authorization), signed copies of the award letter and NIET document which shall form an integral part of the license agreement.

18. The licensee shall undertake to pay the full amount of licence fee / dues regularly as per the award / agreement and perform all the covenants of the agreement even he/they have requested for appointment of Arbitrator and / or during the course of arbitral proceedings (if applicable).

19. Maximum **60 days** of gestation period after completion of business incubation period/handover of site (as per the case) shall be applicable. License fee shall be payable after completion of Gestation period or commencement of business, whichever ever is earlier.

Note: In case concession/ license period of incumbent licensee is not over, then, date of hand over of site shall not be later than 7th day of expiry of incumbent license or expiry of business incubation period (whichever is later).

20. However, the successful tenderer shall be required to submit Security Programme as per Format A & A-1 available on BCAS website <http://esahaj.gov.in> through AAI within 05 days from date of issue of award letter. Any observations regarding shortcomings in Security Programme will be communicated by RDCOS and if compliance report is not received by BCAS, it will be presumed that the concessionaire is unwilling or unable to meet the shortfall and the application for approval will be deemed to be cancelled. AAI, Visakhapatnam will not responsible for delay in getting security clearance from BCAS (if applicable).

21. Water charges (if applicable)/Electricity charges are payable as per actuals. Electricity/Water meters, as applicable, shall be arranged by the licensee and are to be installed in coordination with concerned department of AAI.

22. Built-up space shall be provided by AAI and the fabrication of the counter has to be done at your own cost (as applicable). The structure/counter for the purpose is to be erected by the licensee should be as per the design, drawing and specification approved by AAI at the cost of the licensee (as applicable).

23. The licensee shall adhere to all directives issued by AAI/BCAS from time to time.

24. All other terms and conditions mentioned in the NIET along with this award letter shall form part and parcel of the license agreement.

25. The Menu and rates at which AAI staff (Regular/Contractual and CISF) and other staff (Airlines staff, GHA staff etc.) are to be charged are appended as ANNEXURE: 2 and ANNEXURE: 3 of this LOIA, respectively.

26. Staff canteen facility is not allowed for passengers.

27. AAI at its discretion may allot the paved land, upon request for usage and the allotment shall be on applicable (Paved land) space rents.
