2. Jt. GM (Commercial) AAI, CHQ, shall be the Officer-In-Charge of the work. You are requested to attend the office of Jt. GM (Commercial), AAI CHQ within 30 days of Award to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value Rs. 100 (Rupees One hundred only) and the cost of stamp paper and related costs shall be borne by you.
3. The Earnest Money Amount of **Rs. 1,79,000/- (Rupees One Lakh Seventy-Nine thousand)** received along with your tender will be refunded through CPP Portal on submission of Security Deposit in the form of a Bank Guarantee and confirmation thereof by the respective Bank.
4. Within 30 days of issue of Award Letter, you shall submit to AAI, a Security Deposit as per clause 7.1 (a) of the draft Agreement for an amount of **Rs. 6,96,900 (Rupees Six Lakh Ninety-Six thousand and Nine Hundred only)** in the form of Bank Guarantee. Bank Guarantee shall mean Bank Guarantee issued from Nationalized /Scheduled commercial Banks as per Reserve Bank of India guidelines in the format as per Annex-3 of the RFP/draft Concession Agreement. No Bank Guarantee shall be acceptable from Cooperative Banks (even scheduled)/ Societies/Payment Banks or by means of FDR. Bank charges shall be borne by the agency.
