2	Tentative Location	Arrival Side Area 6 Sqm.
3	Period of the Licence	03 (Three) Years
4	Licence Fee	रुपये . 100786.00+750.00+18276=Rs.119812=00(Quoted licence fees + Utility charges @10% of space license(Rs.1250/-per sqmtr p.m.)-A.C. Space + GST @.18% on Total amount Rs. 101536.00) License fee should be paid on or before 10 th of the same month, failing which interest on delayed payment at the rate of 9% per annum shall be charged from the due date for delay period of upto 30 days and if delay is for more than 30 days, then interest at the rate of 18% per annum shall be charged from the due date, for entire delay period.
5	Charges for electricity & Water	As per Bills issued at applicable rates.
6	Security Deposit	Rs. 479248/- (Rupees Four Lakh Seventy Nine Thousand Two Hundred & Forty Eight only) amounting to 4 (Four) months equivalent License fee of the first year to AAI as an interest free Security Deposit shall be paid in the form of DD/Pay order/Bank Guarantee in favour of Airports Authority of India, Agra Airport within 15 days from the date of issue of this award letter.

		The SD amount equivalent to four months License fee if it is to be submitted in the form of Bank Guarantee then the same BG should be from any scheduled commercial bank (Bank Guarantee from co-operative bank, even scheduled, will not be accepted) or the Security Deposit may be submitted by way of NEFT/RTGS/DD/PO. The BG should be valid for the complete period of licence plus 6 months beyond the licence period. 9	Obligation of Govt laws/rules	The licensee, his agents and servants shall observe, perform and comply with all rules and regulations of Shop and Establishment Act, Factories Act, Industrial Disputes Act, Minimum wages Act and any rules and regulations made by Govt./Airports Authority of India.
10	Business Incubation period	15 days from the date of issuance of LOIA. It is obligatory for the licensee to complete all the formalities/conditions of award as specified in the Notice Inviting Tender and this LOIA.
11	Gestation Period	30 days reckoned from the expiry of business incubation period or start of work whichever is earlier.

12. It may be noted that the Earnest Money Deposit of the successful bidder may be forfeited and the bidder shall be liable to be debarred for further participation in AAI's tender(s) /e-tender(s) for a period of 01 (one) year, on account on non-completion of the following:

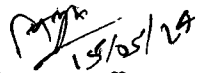
- Acceptance of the offer within 07 (seven) days from the date of issuance of the award letter addressed to the party.
- Payment of advance license fee for one month within 15 days from the date of issuance of the award letter.
- Payment of Performance Security Deposit within 15 days from the date of issuance of award letter.

- d) Execution of the Agreement within 15 days from the date of issuance of award letter
(on stamp paper of appropriate value, related costs to be borne by the Licensee).
- e) Commencement of the facility within gestation period.
13. All security guidelines shall be applicable. Necessary security clearance shall be obtained by the Licensee for obtaining AEP for their staff. BCAS mandates like security clearance and security program must be completed as per BCAS norms and Govt. of India policy.
14. All liasoning/correspondences with IAF or other Govt. agencies regarding entry of vehicle in IAF premises and IAF entry pass shall be made by the Licensee himself.
15. One copy of this award letter may be returned to this office duly signed along with the acceptance letter /token of having accepted the terms and conditions of the award.
16. In the event of the Licensee committing any breach of the terms and conditions of the license agreement, the Authority may without prejudice to other rights and remedies be entitled to forfeit the Security Deposit or any part thereof. On the expiration or earlier determination of the license the Authority shall return the Security Deposit or part thereof which has not been forfeited as aforesaid, to him, without interest.
17. In accordance with the directions of Government of India, cashless transaction system is being promoted by AAI and hence you are also instructed to use the Point of Sales (PoS)/Swipe Machines from the inception of the contract period. Apart from it, all the available modes of e-payment should be followed at your outlet. Licensee shall mandatorily employ at least two different e-payment modes at all times.
18. Agra Airport is a plastic free zone. Hence, you will ensure that no single use plastic is used at your outlet.
19. All the above conditions along with those mentioned in the E-tender shall be binding on the licensee.
20. This award letter, Handing over/taking over Note (to be signed) and all terms and conditions as mentioned in the e-tender shall be part and parcel of the agreement to be executed between Airports Authority of India and M/s Taj International Taxi Services, 61/65, Rasoolpur, Sarai Khwaja, Agra Cantt, Agra.
