4. The EMD shall be forfeited and you may be debarred from further participation in AAI's tender for a period of five years on account of non-compliance with any of the following terms & conditions:-
 - i. Acceptance of the offer within 10 days of the receipt of award letter.
 - ii. Payment of advance Licence fee for one month Rs 9/- (Rupees Nine only) within 15 days of acceptance letter in the form of DD in favour of Airports Authority of India, Nagpur.
 - iii. Payment of Security Deposit equal to last six months quoted licnese fee of Rs 87/- (Rs. Eighty Seven only) in the form of Demand Draft in favour of Airports Authority of India, Nagpur Within 15 days of the acceptance letter.
 - iv. Execution of the agreement as per the format given in the Tender document within 30 days of acceptance letter. The agreement should be executed on non-judicial stamp paper of Rs 100/- value in duplicate and a passport size photograph of the Licensee is pasted on each copy the cost of stamp paper shall be borne by you.
 - v. Commencement of the facility from the date as decided by the Authority.
