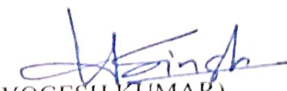

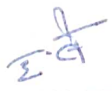
14 Decision:

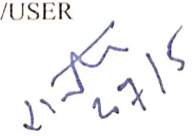
CWC Level-I deliberated the case and decided to open the price bid of following Four firms, who are satisfying the eligibility conditions laid down in the tender.
