- 16 Any other observation relevant to the case :
- 1) M/s Siva Enterprises, Chennai has submitted all the documents as per eligibility conditions of the tender. Hence their offer is technically acceptable.
 - 2) M/s Babu, Chennai has submitted all the documents as per eligibility conditions of the tender pertaining to M/s B.V. Enterprises, wherein Name of the Sole Proprietor is Shri. Babu and Trade Name is M/s B.V. Enterprises. However in the CPPP Procurement Portal there is no mention of M/s B.V. Enterprises and Name of Bidder as well as Company Name is shown as "Babu"
- 17 It is submitted that CEO vide e.mail Dt. 10-06-2023 has sought clarification from M/s Babu that the Company Name and Bidder Name displayed is "Babu" in e-procurement portal generated documents whereas in the eligibility documents and financial documents the company name is mentioned as M/s B.V. Enterprises and Sole proprietor name is mentioned as Shri. Babu. In response, M/s Babu vide e.mail Dt. 12-06-2023 has attached letter Dt. 12-06-2023 wherein it is intimated that ;

"....In response to above clarification e-mail, I submit that my company name is M/s B.V. Enterprises and myself sole proprietor name is B. Babu. While doing registration in CPPP I have erroneously entered the company name as BABU. But all my documents are in name of M/s B.V. Enterprises. Now, I have applied for new digital signature and will make new registration in CPPP portal. The inconvenience caused is regretted please."

18 **OBSERVATIONS OF CWC-I HELD ON 16-06-2023**

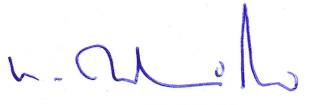
- a CWC-I observed that M/s Siva Enterprises, Chennai has submitted all the documents as per eligibility conditions of the tender and their offer is meeting the eligibility conditions of the tender and is technically acceptable.
- b CWC-I observed that M/s Babu, Chennai has submitted all the documents as per eligibility conditions of the tender which are pertaining to M/s B.V. Enterprises, wherein the name of Sole proprietor is shri. Babu and Trade Name is M/s B.V. Enterprises. However in the documents generated through CPPP portal there is no mention of M/s B.V. Enterprises and name of bidder as well as Company Name is shown as "Babu". CWC-I also observed that on seeking clarification from the firm M/s Babu, they have replied that their company name is M/s B.V. Enterprises and Sole Proprietor name is Shri. B. Babu and while doing registration in CPPP portal they have erroneously entered the company name as "Babu", but all their documents are in the name of M/s B.V Enterprises. The firm has further intimated that they have applied for a new digital signature and will make new registration in CPPP portal.

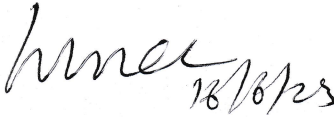

19 DECISION OF CWC-I HELD ON 16-06-2023

- a CWC-I deliberated the case and observed that M/s Siva Enterprises, Chennai has submitted all the documents as per eligibility conditions of the tender and their offer is meeting the eligibility conditions of the tender and is technically acceptable.
- b CWC-I deliberated the case and noted that all the documents submitted by the firm M/s Babu, Chennai are in the name of M/s B.V. Enterprises, Chennai. CWC-I also observed that M/s Babu has clarified that their company name is M/s B.V. Enterprises and Sole Proprietor name is Shri. B. Babu and while doing registration in CPPP portal they have erroneously entered the company name as "Babu". CWC-I opined that the firm is at fault in entering their company name incorrectly in the e-procurement portal while enrolling in CPPP. Hence, CWC-I decided that the offer of M/s Babu, Chennai cannot be accepted.
- c CWC-I observed that the case has become a Resultant Single Tender (RST)
- d Hence, CWC-I decided to re-tender the case on Open Tender basis through two part bid system through e-procurement so as to receive more number of valid and competitive offers. CWC-I decided that the E-Procurement Tender ID : 2023_AVNL_153078_1 must be cancelled in the e-procurement portal.
