10	Firms at Sl. No. 01, 02, 03 & 04 has submitted requisite documents at https://etenders.gov.in . From the enclosed documents submitted by the firms, it is observed that: 1. Firm at Sl. No. 01, M/s Raj Builders, JBP has not submitted hard copy of EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for EMD and affidavit for legal requirement. Accordingly, clarification was raised on 20.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. Firm had not responded against clarification. Subsequently, clarification was raised again on 07.07.2023, firm was given 07 days' time but firm had not replied again. Also the validity of EMD submitted is 90 days. In view of the above, firm is not meeting the required TE eligibility criteria. 2. Firm at Sl. No. 02, M/s Shiva Builder, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for T&C Part-I, Part-II, Part-III, Part-IV, GST rate and HSN & SAC Code, make in India certificate, Affidavit for legal requirement & Power of Attorney. Accordingly, clarification was raised on 20.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. In reply, firm had submitted proper documents for Power of Attorney but not submitted proper documents for T&C Part-I, Part-II, Part-III, Part-IV, GST rate and HSN & SAC Code, make in India certificate and affidavit for legal requirement. Subsequently, clarification was raised again on 07.07.2023, Again firm was given 07 days' time. In reply, firm has submitted proper documents for T&C Part-I, Part-II, Part-III, Part-IV, GST rate and HSN & SAC Code, make in India certificate and affidavit for legal requirement. In view of the above, firm is meeting the required TE eligibility criteria.						

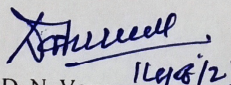
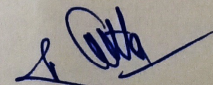
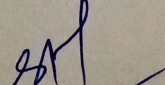

3. Firm at Sl. No. 03, M/s Brijesh Sonker, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for T&C Part-I, Part-II & Part-III. Accordingly, clarification was raised on 20.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. Firm had not responded against clarification. Subsequently, clarification was raised again on 07.07.2023, Again firm was given 07 days' time. In reply, firm has submitted proper documents for T&C Part-I, Part-II & Part-III. In view of the above, firm is meeting the required TE eligibility criteria.
4. Firm at Sl. No. 04, M/s S.R. Associates, JBP had submitted EMD amounting Rs. 1,27,000.00 instead of Rs. 1,27,500.00. However, firm has submitted **EMD of Rs. 1000.00 Dated 14.06.2023 later**. Bid submission end date of this tender is 06.06.2023, the same are mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for Registration certificate, Affidavit for legal requirement & T&C Part-III. Accordingly, clarification was raised on 20.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. Firm had not responded against clarification. Subsequently, again clarification was raised on 07.07.2023, Again firm was given 07 days' time. In reply, firm has submitted proper documents for Affidavit for legal requirement, T&C Part-III.
- For Registration certificate, earlier firm had submitted MES Registration upto Rs 25 Lakhs but as per eligibility criteria registration value was not acceptable (since estimated value is Rs. 52.63 Lakhs) subsequently clarification was raised. Now firm, has submitted PWD registration dated 08.06.2023 with validity 07.06.2033.
- In this connection, it is submitted that tender opening date of this tender was 10.06.2023 and as per clause no. 02 of T&C part-I: Instruction to tenderers "..... The tenderer must have valid registration as on tender opening date".
- It is submitted that, firm has **not submitted EMD of full amount i.e. Rs. 1,27,500.00** within bid submission closing date, as per tender conditions.
- In view of the above, firm is not meeting the required TE eligibility criteria.**

(b) Estimated cost above 60 Lakhs – not less than 7.00 Lakhs of the estimated cost. Note: Solvency certificate and Working capital certificate from scheduled bank to be enclosed. Working Capital Certificate & Solvency certificate having validity on bid submission end date (validity must be clearly mentioned in certificate).
