- 10 Firms at Sl. No. 01, 02, 03, 04, 05 & 06 has submitted requisite documents at <https://etenders.gov.in>. From the enclosed documents submitted by the firms, it is observed that:
1. Firm at Sl. No. 01, M/s Sonal Construction and Engineers, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for registration certificate, working capital certificate and solvency certificate. Accordingly, clarification was raised on 27.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. In reply, the firm, for registration certificate had intimated that "as it was submitted earlier too that in MES, registered in E class means one can applicable for tender limit up to 50 lakhs. For reference, experience of 43.15 lakh of MES and 28.92 Lakh of AVNL itself was attached"
- Further, firm had not submitted proper documents for working capital certificate and solvency certificate. It is submitted that earlier in VFJ, one contract "Replacement of existing HPSV 70w/150w/250w/400w HPSV street light luminaries to LED fittings 35w/45w/90w/120w in VFJ Estate (900 Nos.)" was awarded to M/s Sonal Construction and Engineers, JBP of amount Rs. 28.92 Lakhs.
- In view of the above, clarification was raised on 11.07.2023 for submission of proper documents of working capital certificate and solvency certificate. Again firm was given 07 days' time. In reply, firm has submitted proper documents for working capital certificate and solvency certificate.

For registration certificate, it is submitted that, firm is registered in MES in class E category with upper tendering limit up to Rs. 25 lakhs. In present case, the estimated cost is Rs. 38.00 lakhs which is more than the tendering limit of this firm.

In this connection, it is submitted that As per appendix 3.5 of MES Manual on Contracts, 2020, Notes 01 "After opening of Cover 1, if the number of MES enlisted contractors of eligible class as well as un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT are less than 7(Seven), applications in respect of contractors one class or two classes (in case of remote and difficult areas to be decided as per list circulated by CE command/ADG) below the eligible class shall also be considered subject to fulfilment of other eligibility criteria given in the NIT. Therefore, MES contractors one class below (two classes below in case of remote and difficult areas) may also bid for this tender. However, contractors of one/two classes below the eligible class shall not be considered in case their present residual work in hand is more than twice their present tendering limit. Such bidders shall upload in their Cover-1 bid details of works in hand showing names of work, names of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation."

Accordingly, vide letter no. 84/RD2214/2023-24/EOC dated 02.08.2023 firm was asked to submit **present residual work on your firm**. In reply, vide letter no NIL dated 03.08.2023 firm has intimated that,

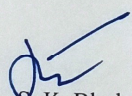
1. At the time of bidding that is dated 08.06.2023, 09.06.2023 and 12.06.2023, my firm was absolutely clean. An affidavit was also submitted by me and was absolutely true.
2. Now on 21 July 2023 there is an FIR registered by CBI, Jabalpur against my firm.
3. Till date neither my firm is blacklisted nor banned in any department but as still you are free to reject my above mentioned bids.

In reply, firm has not intimated about present residual work on firm.

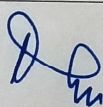
In view of the above, firm is not meeting the required TE eligibility criteria.

2. Firm at Sl. No. 02, M/s S.R. Associates, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for registration certificate, affidavit for legal requirement and T&C Part IV. Accordingly, clarification was raised on 27.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. In reply, firm had submitted proper documents for Affidavit for legal requirement and T&C Part IV, but not submitted proper documents for registration certificate. Subsequently, clarification was raised on 11.07.2023. Again firm was given 07 days' time. In reply, firm has given reference of MES tender documents for considering one class below the eligible class. Firm has forwarded appendix 'A' to Notice Inviting tender and as per point no 01 of Notes

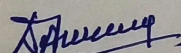
"In case after opening of cover -1, the number of MES enlisted contractors of eligible class as well as un-enlisted contractors if any, fulfilling the other eligibility criteria given in NIT are less than 7 (seven). Applications in respect of contractors one class or two classes (in case of remote and difficult areas to be decided as per list circulated by CE command/ADG) below the eligible class shall also be considered subject to fulfillment of other eligibility criteria given in the NIT. Therefore, MES contractors one class below (two classes below in case of remote and difficult areas) may also bid for this tender. Such contractors (one/two classes below the eligible class) shall not be considered in case their present residual work in hand is more than Five Times their present tendering limit. However, in case such contractors fulfill the criteria of upgradation to the stipulated eligible class based on past experience of completed works (individual work experience and / or average annual turnover, as applicable) and financial soundness (solvency / financial soundness and working capital), the ceiling of present residual work will not apply and they will be considered for issue of tender, such bidders shall upload in their cover-1 bid details related to residual work in hand like details of works in hand showing names of work, names of Accepting Officers, contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. Such contractors, if claim to fulfil the criteria of upgradation shall also upload the requisite information/ documents in support of upgradation. These details shall be verified by the tender issuing Authority from concerned formations in case bids of such contractors are considered for evaluation".



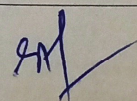

As per appendix 3.5 of MES Manual, Notes 01 "After opening of Cover 1, if the number of MES enlisted contractors of eligible class as well as un-enlisted contractors, if any, fulfilling the other eligibility criteria given in NIT are less than 7(Seven), applications in respect of contractors one class or two classes (in case of remote and difficult areas to be decided as per list circulated by CE command/ADG) below the eligible class shall also be considered subject to fulfilment of other eligibility criteria given in the NIT. Therefore, MES contractors one class below (two classes below in case of remote and difficult areas) may also bid for this tender. However, contractors of one/two classes below the eligible class shall not be considered in case their present residual work in hand is more than twice their present tendering limit. Such bidders shall upload in their Cover-1 bid details of works in hand showing names of work, names of Accepting Officers, Contract amounts, dates of commencement and completion (stipulated) and progress as on bid submission date. These details shall be verified by the Tender Issuing Authority from concerned formations in case bids of such contractors are considered for evaluation."

The firm is registered in MES in class E category with upper tendering limit up to Rs. 25.00 lakhs. In present case, the estimated cost is 38.00 lakhs which is more than the tendering limit of this firm.

vide letter no NIL dated 15.07.2023, firm has intimated that residual work in hand is 38.44 Lakhs.

It may be noted that the firm complies to the past performance criteria as per TE condition according to which firm can submit "One similar completed works costing not less than amount equal to 80% of the estimated cost". Details are enclosed in evaluation matrix.

Also it may be noted that firm is fulfilling the other TE eligibility criteria.

In view of the above, in order to get better competition, VFJ can consider this offer as per appendix 3.5 of MES Manual on Contracts, 2020, Notes 01, as firm is fulfilling the criteria to participate in tender of one class above the eligible class and firm is meeting the required eligibility criteria.

3. Firm at Sl. No. 03, M/s Amit Construction, JBP has submitted EMD mentioned in the above table. During scrutiny it was found that the firm has submitted all the documents properly.

In view of the above, firm is meeting the required TE eligibility criteria.

4. Firm at Sl. No. 04, M/s S.N.S. Rai, JBP has submitted EMD mentioned in the above table. However, there was error in name, which was rectified by the firm later. During scrutiny of other documents it was found that the firm has submitted all the documents properly.

In view of the above, firm is meeting the required TE eligibility criteria.

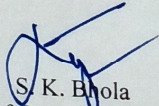
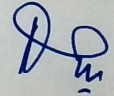
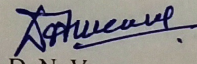
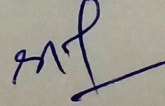
5. Firm at Sl. No. 05, M/s Industrial Instruments, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for work completion certificate, T&C Part-I, Part-II and Part-III. Accordingly, clarification was raised on 27.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. In reply, firm has submitted proper documents for work completion certificate, T&C Part-I, Part-II and Part-III.

In view of the above, firm is meeting the required TE eligibility criteria.

6. Firm at Sl. No. 06, M/s Udairaj Infra Power Private Limited, JBP has submitted EMD mentioned in the above table. During scrutiny for other requirements, it was observed that firm had not submitted proper documents for working capital certificate, T&C Part-I, Part-II, Part-III Part-IV, partnership deed, applicable GST rate and HSN & SAC code, make in India certificate, power of attorney & affidavit for legal requirement. Accordingly, clarification was raised on 27.06.2023 (Placed in file) through CPPP system for submission of deficient documents. Firm was given 07 days' time to reply against the raised clarification. In reply, firm had submitted proper documents for T&C Part-I, Part-II, Part-III, Part-IV, applicable GST rate and HSN & SAC code, make in India certificate and affidavit for legal requirement, but not submitted proper documents for working capital certificate, power of attorney and proprietorship or partnership documents. Subsequently, clarification was raised on 11.07.2023. Again firm was given 07 days' time. In reply, firm has submitted proper documents for working capital certificate, power of attorney and partnership documents.

In view of the above meeting the required TE eligibility criteria.

Turn over: Average Annual Turnover during last Three (03) years, ending 31st march of the previous financial year will be at least 30% of the estimated cost. The bidder's financial capability will be decided based on the average annual turnover.

Solvency certificate: The firm should be solvent to an amount equal to or greater than 1/3 of the estimated cost OR Financially sound for engagement equal to or greater than the estimated cost.

Working capital certificate: Working capital certificate for (a) Estimated cost up to 60 Lakhs – not less than 1/10 of the estimated cost.

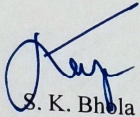
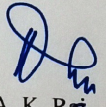
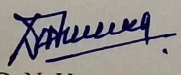
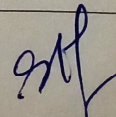
