a) Three similar works each costing not less than 40% of the estimated cost. (Rs. 10.00 Lakhs)

b) Two similar works each costing not less than 50% of the estimated cost. (Rs. 12.50 Lakhs)

c) One similar work costing not less than 80% of the estimated cost. (Rs. 20.00 Lakhs)

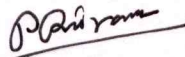

11.	Deliberation/ discussion: All the Three participated firms are found to be technically eligible as per Eligibility Criteria. Further as per Tender Condition, participating Firms are required to upload sealed and signed copies of Tender Documents, Instruction to Bidders, Eligibility Criteria, Technical Specifications, General & Special Conditions of Contract. It is observed that M/s J. K. Enterprises, Ambernath & M/s Vijayan Enterprises, Ambernath have					

	uploaded only Tender Document & have not uploaded other Documents viz. Instruction to Bidders, Eligibility Criteria, Technical Specifications, General & Special Conditions of Contract during online Tender Submission. Hence EO Civil vide email Dtd. 21.06.2023 requested both firms to submit required sealed & signed documents. In response M/s J. K. Enterprises, Ambernath & M/s Vijayan Enterprises, Ambernath submitted required sealed and signed documents through email Dtd. 22.06.2023 & 23.06.2023 respectively. Thus all Three participating Firms are technically eligible and also have fulfilled required criteria of uploading / submission of sealed and signed Tender Documents. Hence recommended for opening the price bids of all Three participating firms.

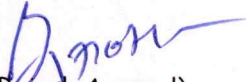
