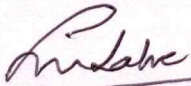

11.	Deliberation/ discussion: All the Four participated firms are found to be technically eligible as per Eligibility Criteria. Further as per Tender Condition, participating Firms are required to upload sealed and signed copies of Tender Documents. It is observed that M/s J K Enterprises, Ambarnath & M/s Vandan Enterprises, Ambarnath have not uploaded required Tender Documents during online Tender Submission. Hence EO Civil vide email Dtd. 10.06.2023 requested both firms to submit required sealed & signed tender documents. In response both firms submitted required documents through email. Thus all Four participating Firms are technically eligible and also have fulfilled required criteria of uploading / submission of sealed and signed Tender Documents. Hence recommended for opening the price bids of all Four participating firms.
12.	Decision: MTPF CWC-II (Fy) after detailed deliberations decided to open the Price Bids of all Four Technically Eligible participated Firms namely, 1. M/s AGS Enterprises, Ambarnath, 2. M/s J. K. Enterprises, Ulhasnagar, 3. M/s Sunbud Multiventures Pvt. Limited, Ambarnath, 4. M/s Vandan Enterprises, Ambarnath.
