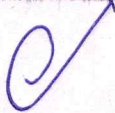

11.	Deliberation/ discussion: 1. Four Firms namely M/s Hindustan Construction Co. Ulhasnagar, M/s Vandan Enterprises, Ambernath, M/s R. R. Electricals, Ambernath & M/s Golden Construction, Kalyan participated in the subject tender through etenders.gov.in. 2. It is observed that M/s Golden Construction, Kalyan forwarded required EMD with delay i.e. on 24.07.2023 instead of 11.07.2023 as elaborated under Point No. 9 above. Also the documents uploaded by Firm with online Tender including <u>Scanned copy of EMD GST Reg & Pan Card, Scanned copy of Fin. Turnover for last 3 years certified by CA, scanned copy of sealed & signed declaration</u> are not visible. The message appears that 'there was an error opening this document. The file is damage & could not be repaired'. The only documents visible are the scanned copies of similar work executed during last 7 years. 3. In view of para 2, above the Firm M/s Golden Construction, Kalyan is considered as disqualified as the Firm has not submitted required EMD physically before due date & time. 4. The other Three participated firms are found to be technically eligible as per Eligibility Criteria. Further as per Tender Condition, participating Firms are required to upload sealed and signed copies of Tender Documents, Instruction to Bidders, Eligibility Criteria, Technical Specifications, General & Special Conditions of Contract. 5. It is observed that M/s Vandan Enterprises, Ambernath have uploaded required declaration & M/s Hindustan Construction Co., Ulhasnagar has uploaded signed copies of all Tender documents. Further M/s R. R. Electricals, Ambernath has uploaded Undertaking regarding Technical Specification only. Hence EO Civil vide email Dtd. 27.07.2023 requested M/s R. R. Electricals, Ambernath & M/s Hindustan Construction Co. Ulhasnagar to submit required sealed & signed documents. 6. In response M/s Hindustan Construction Co. Ulhasnagar forwarded required declaration vide letter No. HCC/MTPF(AVNL)/GEN-TA/2023-24/02 Dtd. 28.07.2023 & M/s R. R. Electricals,

	Ambernath forwarded required declaration on Firm's letter head through email Dtd. 04.08.2023. 7. Thus Three participating Firms except M/s Golden Construction, Kalyan, are technically eligible and also have fulfilled required criteria of uploading / submission of sealed and signed declaration w.r.t. Tender Documents. Hence it is recommended for opening the price bids of Three participating firms namely M/s Hindustan Construction Co. Ulhasnagar, M/s Vandan Enterprises, Ambarnath, M/s R. R. Electricals, Ambarnath.
12.	Decision:
	MTPF CWC-II (Fy) after detailed deliberations decided to open Price Bids of Three Technically Eligible participated Firms namely 1. M/s Hindustan Construction Co. Ulhasnagar 2. M/s Vandan Enterprises, Ambarnath 3. M/s R. R. Electricals, Ambarnath. Further the delayed EMD submitted by M/s Golden Construction, Kalyan may be returned to Firm & the Firm may be advised to submit required EMD before due date & time in future tenders.
