A) Experience of having successfully completed similar type of works during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) Three similar works each costing not less than 40% of the estimated cost.

b) Two similar works each costing not less than 50% of the estimated cost.

c) One similar work costing not less than 80% of the estimated cost.

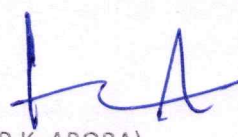

11.	Deliberation: a) Total 5 firms were responded against tender. Technical offers of all participants 5 firms are opened. Firms documents downloaded and checked. b) EMD is required of `20,000/- with validity of six months and actual is to be submit to AVNLIOL, Ambarnath on or before tender opening date i.e. 20/07/2023 as per <i>Instructions to Tenderers clause no 1 and as per Evaluation Criteria clause no. 04</i>. Out of the participated 5 firm, valid EMD submitted by 4 firms i.e. 1) M/s R.R. Electricals, Ambarnath, 2) M/s Chaman Construction, Ambarnath, 3) M/s Balaji Enterprises, Ambarnath and 4) M/s Hindustan Construction Co., Ulhasnagar, dis-Thane. One firm M/S Golden Construction, Kalyan ,dis-Thane has not submitted EMD as per tender requirement and accordingly their offer was disqualified. c) As per as per <i>Instructions to Bidders and Evaluation/Eligibility Criteria, The bidder shall upload Self Declaration on Firm's letter head that the firm has read all the Evolution /Eligibility Criteria laid down hereby and clearly understood the same before quoting for the Tender</i>. M/s Chaman Construction have not uploaded the Self Declaration Certificate. The firm asked to submit the same. M/s Chaman construction send valid Self declaration certificate through email , kept in case file. d) firms 1) M/s R.R. Electricals, Ambarnath, 2) M/s Chaman Construction, Ambarnath, 3) M/s Balaji Enterprises, Ambarnath and 4) M/s Hindustan Construction Co., Ulhasnagar, dis-Thane are consider eligible as per laid down eligibility criteria above at para 10 A) and B). e) The firms have also complied with all technical requirements of the tender. CWC-I therefore considers offer of 1) M/s R.R. Electricals, Ambarnath, 2) M/s Chaman Construction, Ambarnath, 3) M/s Balaji Enterprises, Ambarnath and 4) M/s Hindustan Construction Co., Ulhasnagar, dis-Thane. are technically acceptable.
12.	Decision: Based on above deliberation, CWC -1 decided to open price bid of technically acceptable firms 1) M/s R.R. Electricals, Ambarnath, 2) M/s Chaman Construction, Ambarnath, 3) M/s Balaji Enterprises, Ambarnath and 4) M/s Hindustan Construction Co., Ulhasnagar, dis-Thane.
